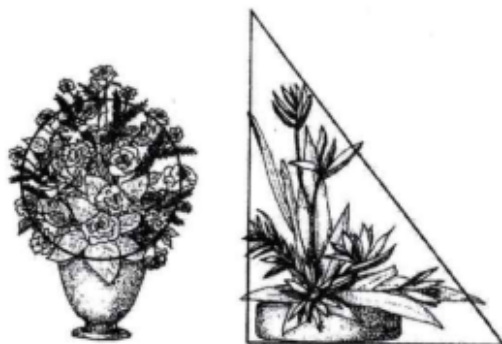
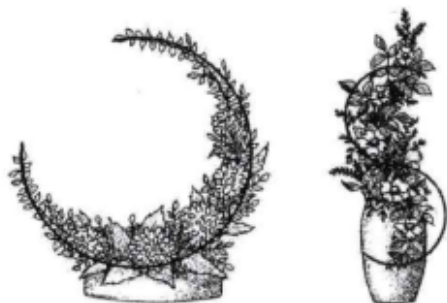


## COURSE 1 STUDY SUBJECTS
