#### **Blue Star Memorial Markers Co-Chairman, Shirley Lipa**

The Stockton Garden Club replaced a By-Way marker and the Red Bluff Club has ordered a Memorial Marker to be placed in the Tehama District Fairgrounds.

One of the most frustrating parts of the last two years was the National Forest Services offices were closed and no one was processing the checks and issuing the much awaited certificates to present to a family or individual. From staff working from home and not going into the office to pick up mail to running out of the certificate to fill out. Well hopefully that is all behind us and we look forward to receiving the certificates when our donations are mailed in.

**President’s Project – San Diego’s River Center at Grant Park, Robin Pokorski**

We are so thankful to the many that have generously donated to The River Center at Grant Park. We are thrilled to announce that an additional \$2,875 has been sent to the Foundation bringing our fundraising efforts to \$10,030.00. We are nearly halfway through this term and nearly halfway to our goal of \$25,000 – together we can make the Sensory and Ethnobotanic Gardens a reality.

**Scholarship Chairman, Martha Smyser**
