## **Attachment B Officers' Reports**

### **Parliamentarian, Greg Pokorski**

Since Convention this officer has reviewed the six sets of minutes from that meeting, worked with the president on agendas for this meeting, and responded to inquiries and requests from several districts and garden clubs, including the review of bylaws.

Issues that are seen in club and district bylaws:

- Confusion between executive committees and executive boards. They are not the same thing. See recent articles in *WACONIAH* and *Golden Gardens eNews*.
- Clubs and districts who are members of CGCI's GTEP program must abide by IRS language requirements. I see some organizations forgetting why those provisions are in their bylaws and trying to change them. Any organization that is a member of the GTEP program needs to re-read the GTEP Handbook (on our website) before changing bylaws.
- If you do any email voting your bylaws must provide for it. I strongly discourage this practice, especially at the club and district level. Don't use it for other than urgent matters that cannot wait until the next scheduled meeting. See NGC and Pacific Region Standing Rules for examples of email voting guidelines. I can provide CGCI's Executive Committee email voting guidelines.
- As usual, CGCI's bylaws and standing rules were updated during the last year. Those changes are posted on our website and included in the new 2017-2019 *Yearbook, Manual & Roster*. Be sure to refer to the most recent version.

I have been asked what our clubs need to know about the Brown Act. Nothing. It guarantees the public's right to attend and participate in meetings of local legislative bodies. It is not applicable to garden clubs.

Club parliamentarians should read and be familiar with *How to Be a Blue Ribbon President*. That can help you better assist your president and your club.

### **Communications Director, Jane McKee**

- A new Board of Directors Contact Information Form was created at the request of the President. The form is to confirm or update the data for all board members.
- Penny Pines:
  - The new webform, created to replace the paper notification form mailed to the CGCI Chairman, went into effect July 1. Clubs have found and started to use the new form.
  - The form is printed to be mailed with check to the Forest Service. The notification to the CGCI Chairman is submitted electronically and goes directly to that chairman eliminating the need for mailing.
  - The webform also generates a spreadsheet that simplifies creating the monthly report. To date there have been over 50 submissions using the new form.
- New Chairman's page:
  - It's under the About CGCI menu.
  - It explains briefly a chairman's duties and lists all current chairmanships. Those chairmanships that have established pages (official projects, membership, awards etc.) are linked to the individual pages and/or forms.
  - Those that don't have an already established individual page can have a special page. Arbor Day is the first of these.
- Online security:
  - The "spoofers" are still out there and continue to try to gather/steal information and funds. Some don't even try to spoof the "from" email address...and I particularly like the "Hello Perko" and "from Migliore Krystal"

- o Following the report of the Equifax hacking, users should be particularly vigilant in changing passwords and reviewing suspicious emails.
- o Consider fraud alerts on individual accounts (maximum \$\$ amount or limit number of transactions) or freezing your account with the 3 credit reporting companies.

### **2017-19 President's Project Resolution *Sustainable and Ever-Growing Scholarships***

Whereas, California Garden Clubs, Inc., hereafter referred to as CGCI, is a 501c3 charitable, educational nonprofit organization, and;

Whereas, The Diamond Years: Seventy-Five Years and Growing published in 2007 for the Diamond Jubilee Celebration, reports the first two scholarship recipients received \$500 each, with the announcement appearing in Golden Gardens in May 1965, and;

Whereas, \$500 awarded in 1965 when allowing for inflation would in 2017 equate to \$3,869.10, and;

Whereas, in recent years we have awarded two \$2,000 scholarships annually to recipients with funds coming from the existing *Scholarship Donations/Life Membership Fund*, and;

Whereas, "The cost of a college degree has increased 1120% since 1978", as reported by the Huffington Post, and;

Whereas, we have many more scholarship applications from well-qualified and worthy students than funding available for the scholarship program, and;

Whereas, the *CGCI Scholarship Endowment Fund*, a Permanently Restricted Fund whose charter appears in the current Yearbook, Manual and Roster beginning on page 108 was adopted at the 79<sup>th</sup> Annual Convention on June 6, 2010, and; now, therefore, be it

Resolved, now is the perfect time for the largest state organization in National Garden Clubs, Inc. to add a bit of "California Style" as we begin to correct this imbalance between the growing need and our ability to meet the need, and;

Resolved, that California Garden Clubs, Inc. adopt "**Sustainable and Ever-Growing Scholarships**" as the 2017-19 President's Project. The purpose of this project is to raise funds to increase the scholarship dollar amount awarded per recipient and/or to increase the number of scholarships awarded beginning in 2019 and in the long run to increase the amount donated to the *CGCI Scholarship Endowment Fund* so that the principle will generate more investment income and it will be available to be awarded as scholarships sooner, and;



Resolved, that donations made by members, clubs, districts, individuals from the general public, and companies be made payable to "CGCI" with "President's Project 2017-19" added in the memo line and be sent to the President's Project chairman, who will keep records of the transactions and forward the donations to the CGCI Treasurer for deposit into the Temporarily Restricted Fund *2017-19 President's Project (Line Code 31511d)*, and;

Resolved, on, or around June 15, (in 2018 and in 2019) the balance will be divided equally, with 50% transferring to the CGCI's Temporarily Restricted *Scholarship Donations/Life Membership Fund (Line Code 31513)*. Should the amount transferred exceed \$5000 per year to the aforementioned fund, the funds received in excess of \$5000 per year may be awarded after the 2020 scholarship year. Funds from this 2017-19 President's Project shall be used to meet the highest scholarship need, as determined by the Scholarship Committee, and;

Resolved, with the other 50% transferring to Permanently Restricted *CGCI Scholarship Endowment Fund (Line Code 31811)*; and shall be treated the same as any other donations to the Scholarship Endowment Fund, and;

Resolved, that any funds remaining in the Temporarily Restricted Fund *2017-19 President's Project* as of June 30, 2019 shall be split equally and transferred to CGCI's Temporarily Restricted *Scholarship Donations/Life Membership Fund (Line Code 31513)* and CGCI's Permanently Restricted *CGCI Scholarship Endowment Fund (Line Code 31811)* for the purposes detailed in the two previous paragraphs.
