Business Meeting #1

President Robin Pokorski called the 77th annual convention of California Garden Clubs, Inc. to order at 8:30 A.M. The Recording Secretary was present.

The Pledge of Allegiance was led by Jerry Thirloway, Palomar District Director

The Conservation Pledge was led by Kay Wolfe, Recycling Chairman

The Inspiration was given by Madelyn Jameson, President, West Valley Garden Club

President Pokorski introduced the Executive Committee seated at the head table; former CGCI Presidents Mary Lou Goodwin, JoAnn Gould, Beverly Brune and Elisabeth Tufo; Pages Sharon Archibald, Alexa Moss and Deedee Speer and Timekeeper, Martha Ann Walter.

President Pokorski introduced the convention's special guest, NGC President Barbara May escorted by former CGCI President Robert Gordon.

Legislation/Government Committee Chairman, Chuck Goodwin asked to be recognized for the good of the organization and made a special presentation to President Pokorski.

Mary Fleer, Credentials Chairman read the first Credentials report and moved to adopt: 138 voting members registered. **PASSED**

President Pokorski declared a quorum was present

Carol Sexton, Registration Chairman gave the first Registration Report: 272 registered.

Carol Sexton, Parliamentarian read the Convention Rules and moved to adopt. PASSED

Rita Desilets, Convention Chairman moved to adopt the Convention Program. PASSED

President Pokorski thanked San Fernando Valley District for hosting the 2008 Convention.

Maryanne Lucas, Chairman of the Minutes Review Committee, moved to approve the Minutes of 2007 Convention Meeting as distributed. **PASSED**

President Pokorski introduced Curt Cecconi, Principal Financial Group.

- As of May 31, 2008 CGCI has 271 clubs with 15,038 members, Associate Plant Societies reported 4281 members for a total membership of 19,319 and Affiliates reported 9826 members
- Banners can be customized for club, district, school, society, affiliates etc. These are a good way to promote CGCI and NGC
- Zip code finder program should be active on the website within two weeks.
- Posters, Cards, bookmarks, rack cards etc are still free but District Directors need to provide number to be ordered
- District rosters are due July 1
- Presented certificates:
 - "Small but Mighty"
 - Crestmoor Garden Club (5 members, 50 years old),
 - "Natural Growth"
 - Paradise Garden Club 34% increase in membership
 - Folsom Garden Club 84% increase in membership
 - It's Garden Thyme Garden Club 94% increase & NGC certificate for largest increase in membership

• Announced NGC contest to increase membership (net increase). The winning state will get to name a new canna cultivar. 2nd Vice President: Julie West

- **Award Finances**: All sponsors for 2007-2008 have remitted payments for the awards presented at 2008 Convention. Approximately 54 sponsors fund 87 awards totaling \$4,350.
- **Policy**: The committee continues to develop policies related to CGCI's website and final report should be available at Convention 2009.
- **Participating Sponsors:** There are 54 Participating Sponsors, a gain of 9 over the past year.
- **Publicity:** A publicity guide is available on the CGCI website. June 26-29 CGCI will have a display table with membership information for both CGCI and NGC at the 8th Biennial Members meeting of the North American Butterfly Association. There is an active link from the NABA.org website to CGCI's website.

• **Strategic Planning:** The Committee recommended that a special committee of past Convention and Board Chairman be formed to investigate reorganizing Conventions/Board meetings to increase revenues for hosts and enhance the experience for members. Suggested topics of review include reducing the number of days/number of reports, making the Chairmen more accessible, eliminate redundancy, provide more educational opportunities. This Special Committee will meet for the first time at this Convention. Members are Mary Lou Goodwin; Shane Looper; Judi Picinini; Linda Riddle and Pat Clayes. Also the Strategic Planning Committee will host a workshop on Saturday and all convention attendees are invited to attend.

• **CGCI 75-Year History Book:** As reported at Winter Board, *The Golden Years* covering CGCI's first 50 years has been data entered. Various portions of this book were referred to over 30 people asking their assistance to update a particular section. Those updates have now been data entered.

• Vista has to surrender their 501c4 status before they can be added, but there are now 89 clubs and districts in the program

• Coming soon:

Website: Clubs/Districts will be able to use CGCI web space at no charge. Each entity will be responsible for maintaining its own space. Blogs established for clubs/districts. This feature will include restricted pages for District Directors and Committee Chairs. Calendar – members will be given password and allowed to post their own info.

President: Robin Pokorski reviewed the past year:

• CGCI President attended 95 events, visited 33 clubs and 19 districts including 13 official visits, and with various members of the Membership Committee greeted thousands of people at events in San Diego, Sacramento and San Francisco

• There is a new look for the website and a new design for banners and bookmarks. Additional publicity tools available to clubs and districts include rack cards and a Fact Sheet posted on the website,

- The process to update CGCI's 75 year history is underway,
- Parliamentary Workshops were conducted at state meetings and over 75 board members, club members and some non-members participated,

• Education: one Tri-Refresher course followed the 2007 Fall Board Meeting and another is planned for September 2008, a water conference will be held in October and two Flower Show, two Landscape Design, one Gardening Study and one Environmental Studies Schools are on the calendar,

• Landscape Design Council commendation certificates were presented at nearly every district visited,

• The first full-color yearbook, presented in a 3-ring binder for easy page addition and replacement was introduced,

- A District Director Training Workshop was held,
- A no-annual fee credit card to secure hotel deposits for CGCI meetings was obtained,

• Principal Financial Group agreed to underwrite the cost of membership cards and provided \$2,000 for grants for the purchase of Blue Star Byway Markers. Principal has indicated that this program may be renewed for 2009 in California,

• Donations for the reforestation of California National Forests have increased substantially,

• The President's Project, the Trail of Trees, is in the second stage of planting specimen trees on the previously barren hillside and a picnic table with a plaque has been installed.

Awards: Nancy Lee Loesch noted the committee is preparing for next year and reminded members to follow the instructions carefully and especially adhere to deadlines. Comments/suggestions may be sent to chairman. Board of Trustees: No report

Budget & Finance: The committee has met and the budget will be presented at the Organization Meeting. **Bylaws:** Mary Jo Noth moved to adopt the following amendments:

• Article V. Section 4 (a)

The Recording Secretary shall: (a) keep minutes of meetings and distribute copies to the board of directors *appropriate recipients* within six weeks of each meeting.

(Rationale: clarifies recipients, i.e. executive committee receives minutes of executive committee meetings, but board of directors does not.) **ADOPTED**

• Article XI Section 8

Convention, registration and credentials chairmen and treasurer, who shall **may** be members of a club in the host district(s), shall **may** be appointed by the president upon recommendation from the host district(s) following the selection of the convention locale.

(Rationale: allows current CGCI chairmen for Registration and Credentials to serve.) ADOPTED

Article XII Section 5

Net proceeds from conventions shall be placed in the General Fund.

Half of the net proceeds from conventions shall be placed in the General Fund and the remaining half may be retained by the Host District(s) or Host Club(s).

(Rationale: specifies distribution of proceeds from conventions.)

Elisabeth Tufo moved to table the amendment until the Boards/Conventions Committee makes a recommendation. The motion was seconded and **PASSED**

Article XII Section 7

The following are budgeted from the General Fund: (a) president's allowance *reimbursement* of up to \$3000.00 \$5000.00 annually for verified expenses incurred for state travel and office expenses including mileage reimbursement in accordance with the current IRS business mileage rate, (b) president's allowance *reimbursement* of up to \$5,000.00 annually for verified expenses incurred in attending two meetings of NGC and one Pacific Region meeting, (c) president-elect's allowance *reimbursement* of up to \$1,500.00 for verified expenses incurred in attending one meeting of NGC and (d) an allowance *reimbursement* of up to \$1,500.00 annually for verified expenses incurred in attending one meeting of NGC and (d) an allowance *reimbursement* of up to \$1,500.00 annually for verified expenses when the Pacific Region director is from California.

(Rationale: current allowance in subsection (a) is insufficient; the increase will allow for reimbursement of more of the CGCI president's official expenses. The increase was proposed by the Board of Trustees and the Advisory Council. Other changes: "reimbursement" is the procedural term, not "allowance".) **ADOPTED**

Winter Board Meeting 2008, Redding: Kathy Bramhall, Cascade District Director, reported 142 registered attendees and net revenue of \$3719.21. Cascade District donated \$500 to the CGCI President's Project.

Nominating: Bob Gordon reported that the committee has started the interviewing process for the 2009-11 term.

Tours: Bob Gordon announced that there will be a "Southern Comfort" tour of Charleston and Savannah gardens in the spring of 2009. The display in exhibit room has details. A minimum of twenty participants are required and a refundable deposit can be made by October 1, 2008.

Youth Team: Beverly Switzer

• The Girl Scout pilot project has been delayed due to a reorganization of Girl Scouts USA. Once the state program has been realigned the CGCI project will resume.

- Eleven essays were received and certificates presented to all entrants
- Three CGCI scholarships have been awarded and a Scholarship Committee co-chairman named,
- There are 21 poster contest winners; five forwarded to Pacific Region
- Three new awards have been established
- Four new youth groups were ratified during 2007

• Moved to ratify Special Education Diggers, sponsored by Riviera Garden Club, Costa Verde District **PASSED**

President's Project: Bev Brune

- The second phase is underway and a picnic table is ready to be installed.
- Three Landscape Design Council certificates have been awarded to the garden and the project.
- First year goal of \$10,000 has been met.
- Fundraising at this convention: Silent auction for 2 trees, baked goods for sale and wine bags for sale with proceeds to project.

President Pokorski announced a recess at 11:30 A.M.

Cascade: Hosted CGCI Winter Board meeting 2008; held awards workshop; updated the speakers directory; selected two Women of the Year; clubs purchased 22 Penny Pines plantations.

Channel Islands: Hosted CGCI President, Robin Pokorski; one club member received a CGCI Landscape Design commendation; clubs support their communities by providing weekly floral arrangements to a post office, maintaining a museum garden, maintaining a church forecourt, providing docents for a Hospice garden tour, holding a standard flower show, manning an Earth Day booth and holding senior workshops at day care facilities; club fundraisers include; wreath making, garden tours, plant sales, garage sales and a Tea.

Costa Verde: District has started writing its 74 year history; held a District horticulture show at South Coast Botanic Gardens; welcomed one new club – Naples Island Garden Club and one Special Education club; celebrated 50th anniversary of The Gardeneers and 80th anniversary of San Pedro Garden Club.

Desert Empire: Held District Flower Show in April; Desert Planters planted two trees at Mesquite High School; Desert Rose Garden Club completed the California City median project; Oasis GC celebrated its 50th anniversary and Boron Garden Club had educational display at the Conservation Resources Farm Poppy Festival.

Greater Los Angeles: No report filed

Humboldt: The African Violet Society held a Mother's Day Plant Sale; The Eureka Sequoia Garden Club raised money for the District by selling plants at the North Coast Garden Event in Trinidad; The Ferndale Garden Club held a Spring Tea; the Fortuna Garden Club held a Standard Daffodil show; Patrick's Point Garden Club held a North Coast Garden Event; and the Southern Humboldt Garden Club held its 57th annual flower show. The club members sign up months ahead then, one or two members donate the flowers (fresh picked from the garden) and supply containers; the District has had a successful Award year due to our Award Chairman who held workshops for clubs, made a presentation at every District meeting, and prepared a display board to show and tell about how simple the procedure can be.
