#### **Housekeeping Items & Other Proposed Amendments**

##### 1. **ARTICLE IV - MEMBERSHIP AND DUES** (page 128)

Sec. 1. The membership of this corporation shall consist of 5 classes: garden clubs, associate plant societies, affiliates, life members and all categories of youth gardeners. Voting memberships shall be garden clubs **and** associate plant societies **and affiliates**. Nonvoting memberships shall be all categories of youth gardeners, **affiliates** and life members.

Rationale: Some clubs appear to be looking for ways to avoid belonging to districts and paying district dues by becoming affiliates. Moving affiliates to nonvoting membership removes one incentive to change.

PASSED.

##### 2. **ARTICLE IV - MEMBERSHIP AND DUES** (page 128)

Sec. 3. All dues are payable on July 1 and delinquent on ~~November~~ **October** 1. Dues shall be payable to CGCI and mailed to the membership chairman who shall transfer the funds promptly to the treasurer. **(a)** Garden Clubs and Associate Plant Societies shall pay annual dues of two dollars twenty-five cents (\$2.25) per capita which shall include dues to NGC, effective July 1, 2008. **(b)** The per capita dues of any new club or associate plant society shall accompany application for membership. Clubs or associate plant societies shall forward dues on a quarterly basis for new members accepted during the previous quarter to the membership chairman. **(c)** Affiliates shall pay annual dues of fifty dollars (\$50.00) regardless of size. **(d)** New clubs **and** associate plant societies **and affiliates** joining CGCI between January 1 and June 30 shall pay one-half of the annual dues for the period up to June 30. ~~which are due July 1 and delinquent November 1~~. They shall be ratified at the winter board meeting or the pre-convention meeting and shall be entitled to representation at the convention. **(e)** If dues are not paid by ~~November~~ **October** 1, clubs and associate plant societies become ineligible for CGCI liability insurance and participation in the CGCI awards program.

***In addition, clubs also become ineligible for the CGCI 501(c)(3) IRS Group Exemption.*** **(f)** All categories of youth gardeners shall pay no dues to CGCI. Membership dues to NGC, including dues for youth gardeners, and dues to Pacific Region shall be paid annually from the general fund. **(g)** Life memberships are honorary and require a onetime contribution of one hundred dollars (\$100.00). Life membership contributions after June 1, 1997 will not include *Golden Gardens*. A club or associate plant society shall pay state dues for all members, including life members.

Rationale: Changing the date to October 1 shortens window to 90 days past date of July 1 when dues become delinquent. Still allows plenty of time for clubs to remit their dues. Liability insurance bills are typically mailed at end of October or first of November so no overlap of delinquent dues vs. eligibility for liability insurance will occur as it does today.

Also, removes affiliates from paying one-half the annual dues (\$50) if they join CGCI between January 1 and June 30. \$50 dues is membership fee regardless of when they join.

In addition, need to make it clear that if a club fails to remit dues on time, the club is not eligible to participate or continue participating in CGCI's 501(c)(3) IRS Group Exemption program.

PASSED.

##### 3. **ARTICLE V - OFFICERS AND THEIR DUTIES** (page 129)

Sec. 2 (c) appoint the parliamentarian, all chairmen of standing and special committees (except the nominating committee, board of trustees, ***advisory council, budget and finance***), and fill vacancies on the board of trustees.

Rationale: Article XV states the immediate past president shall act as chairman of the Advisory Council and Article XII Sec. 6 (a) states the financial secretary shall serve as the chairman so they are not appointed by the President and need to be added as exceptions.

PASSED.

4. **ARTICLE VI – NOMINATIONS AND ELECTIONS** (page 130)

Sec. 2 d (3). At the Fall Board Meeting, in odd-numbered years, the committee shall notify all board members of offices to be filled, such notice to be published in ~~the following issue of~~ *Golden Gardens*.

Rationale: Depending on the publication schedule of *Golden Gardens*, the notice could possibly be published in the "summer" issue since all offices, except that of President, are in fact "open."

PASSED.

5. **ARTICLE IX - DISTRICTS AND DISTRICT DIRECTORS** page 132)

~~Sec. 6. Board meeting chairmen may be appointed by the president upon recommendation from the host district following selection of the Board meeting locale. (new Sec. 6 with renumbering of remaining sections.)~~

Rationale: This wording is similar to Article XI – Annual Meetings. Sec. 8. The President needs to be able to work with the Board Meeting Chairmen and have him/her ratified which is the same process for Convention chairmen. Eliminates inconsistencies of sometimes ratifying a board chairman and sometimes not.

PASSED.

6. **ARTICLE X – CHAIRMEN AND COMMITTEES** (page 133)

~~Sec. 1 There shall be such standing committees as are necessary for the operation of the corporation. The president shall appoint chairmen subject to ratification by the board of directors.~~

~~Sec. 2 Special committees shall be appointed as needed subject to ratification by the board of directors.~~

Strike and replace with:

~~Sec. 1 There shall be such standing and special committees as are necessary for the operation of the corporation. The president shall appoint chairmen (except the nominating committee, board of trustees, advisory council, budget and finance), subject to ratification by the board of directors.~~

Rationale: Combines two sections into one and notes those chairmen the President does not appoint as provided for elsewhere in the bylaws (Article VI Sec. 2 (d) 2; Article XIV Sec. 2; Article XV and Article XII Sec. 6).

PASSED AS AMENDED.

7. **ARTICLE XII – FINANCES** (page 134)

Sec. 6. The finance and budget committee shall: (a) ~~include~~ ~~consist of~~ the financial secretary, who shall serve as the chairman, first vice-president, treasurer, chairman of the board of trustees, and ~~one person~~ ~~up to three persons~~ ~~members~~ who shall be appointed by the president, (b)...

Rationale: By allowing the President to appoint additional people to serve on the Budget & Finance Committee, some or all of the vice presidents may be included so as to become familiar with CGCI's finances, various members of the Board of Trustees, as well as members from the assembly at large.

PASSED.

8. **ARTICLE XII – FINANCES** (page 134)

Sec. 7. The following are budgeted from the General Fund: (a) president's reimbursement of up to ~~\$5,000~~ ~~\$10,000.00~~ annually for verified expenses incurred for state travel and office expenses including mileage reimbursement in accordance with the current IRS business mileage rate, (b) president's reimbursement of up to \$5000 annually for verified expenses incurred in attending two meetings of NGC and one Pacific Region meeting; expenses over and above may be presented to the Board of Directors for approval, ~~in attending two meetings of NGC, one Pacific Region meeting and for state travel and office expenses including mileage reimbursement in accordance with the current IRS business mileage rate,~~ (c) president-elect's reimbursement of up to \$1,500 for verified expenses incurred in attending one meeting of NGC, and (d) a reimbursement of up to \$1,500 annually for verified expenses when the Pacific Region director is from California.

Rationale: ~~Combines \$5,000 presently provided in (a) and \$5,000 presently provided in (b) into one lump sum of \$10,000~~ To cover more of the President's expenses incurred on behalf of CGCI and less out of pocket personally.

PASSED AS AMENDED.

9. **ARTICLE XII – FINANCES** (page 134)

Sec. 10. ~~The financial secretary, treasurer, liability insurance chairman and Golden Gardens finance chairman shall be bonded in equal amounts.~~ **A crime policy that includes Employee Dishonesty coverage Bonds to will be furnished by CGCI and paid from the General Fund.**

Rationale: CGCI has not had a fidelity bond for named positions in several years. The current coverage is provided by a crime policy with blanket Employee Dishonesty coverage and is not restricted to those four chairmanships.

PASSED.

10. **ARTICLE XIV - BOARD OF TRUSTEES** (page 135)

Sec. 2. Immediately following the post-convention meeting in an odd-numbered election year and immediately following the pre-convention meeting in an even-numbered, non-election year, the president shall call a meeting of the board of trustees to elect a chairman and secretary who shall serve for one year and may be reelected for **an one** additional **one-year** term. Four members shall constitute a quorum. If the chairman is unable to represent the trustees at board meetings, the secretary may act as alternate. The board of trustees shall meet upon call of the chairman, or secretary acting in absence of the chairman.

Rationale: Clarifies the original intent of a one-year term followed by one additional one-year term as the maximum time served as Chairman and Secretary.

PASSED.

**Golden Gardens Editor Proposed Bylaw Amendments**

**PROVISO: All bylaw amendments relating to the Golden Gardens Editor including Article V Sec. 1; Article V Sec. 8; Article VI Sec. 1 b(3); Article VII Sec. 1; Article VIII Sec. 1; Article XIII Sec. 1; Article XIII Sec. 3 and Article XIII Sec. 5 shall take effect at the close of the CGCI Convention May 18, 2011.**

**NOTE: If the amendment to Article V Sec. 1 (Item #12) were to fail, the remaining proposed bylaws amendments as respects Golden Gardens Editor will not be presented for consideration.**

PASSED.

Robin Pokorski moved to consider the remaining amendments (#s 11 to 18) at one time. **PASSED.**

Mary-Jo Noth moved to strike a period and insert a semicolon in # 17, Section 3. **PASSED.**

Julie West moved to adopt the following amendments (#s 11 to 18) as amended. **PASSED.**

11. **ARTICLE V - OFFICERS AND THEIR DUTIES** (page 129)

Sec. 1. **(a)** Elected officers shall be president, first vice-president, second vice-president, third vice-president, recording secretary, corresponding secretary, financial secretary **and** treasurer ~~and Golden Gardens editor~~. **(b)** The appointed officer shall be the parliamentarian.

Rationale: Subscriptions for *Golden Gardens* have declined to approximately 3,700 subscribers of which CGCI purchases 375 complimentary subscriptions for club presidents, APS presidents, affiliate presidents and district directors. In addition, individuals who became life members before June 1, 1997 receive subscriptions paid by CGCI. Position does not appear to warrant inclusion on the Executive Committee and could be handled by making the position a Standing Committee Chairmanship under Article VII – Board of Directors.

12. **ARTICLE V - OFFICERS AND THEIR DUTIES** (page 129)

~~Sec. 8. The Golden Gardens editor shall supervise publication of Golden Gardens.~~  
Move this to Article XIII – *Golden Gardens* and renumber #9 to #8.

13. **ARTICLE VI – NOMINATIONS AND ELECTIONS** (page 130)

Sec. 1 b (3). The **treasurer**, recording, corresponding and financial secretaries, ~~treasurer and Golden Gardens editor~~ only shall be eligible for two two-year terms. No officer shall serve longer than four years in any one position except that eligibility restrictions shall not apply to the appointive office of parliamentarian.

Rationale: Removes *Golden Gardens* editor as being limited to two terms since position no longer subject to election.

14. **ARTICLE VII - BOARD OF DIRECTORS** (page 131)

Sec. 1. Composition of the CGCI board of directors shall be: **(a)** officers, **(b)** district directors, **(c)** members of the nominating committee, **(d)** members of the board of trustees, **(e)** members of the advisory council, **(f)** members of the bylaws committee, **(g)** members of the Circle of Poppies, **(h) editor and members of the Golden Gardens**

**committee and (i) all committee chairmen.** One-third shall constitute a quorum. No member shall be entitled to more than one vote.

Rationale: Adds editor and members of the *Golden Gardens* committee to be members of the board of directors under Article VII and clarifies all committee chairmen (including both standing and special committees) are members of the board of directors.

**15. ARTICLE VIII - EXECUTIVE COMMITTEE** (page 132)

Sec. 1. Executive committee of the board of directors shall consist of the president, vice-presidents, recording, corresponding and financial secretaries, treasurer, **Golden Gardens editor** and parliamentarian. A majority shall constitute a quorum.

Rationale: Position does not appear to warrant inclusion on the Executive Committee and could be handled by making the position a Standing Committee Chairmanship under Article VII – Board of Directors.

**16. ARTICLE XIII - GOLDEN GARDENS** (page 135)

Sec. 1 ~~CGCI shall publish an official magazine, Golden Gardens.~~

Strike and replace with:

**Sec. 1 The official publication of CGCI shall be Golden Gardens, electronic or print.**

Rationale: Allows flexibility for future of *Golden Gardens*.

**17. ARTICLE XIII – GOLDEN GARDENS** (page 135)

Sec. 3. **The Golden Gardens editor shall (a) supervise publication of Golden Gardens, (b) keep the cost of publication within the budget adopted by the board of directors; Any additional expenditures shall be presented to the executive committee for approval prior to incurring indebtedness, (c) be chairman of the Golden Gardens Committee and (d) report to the board of directors at all board meetings and conventions. (re-number remaining sections)**

Rationale: Incorporates Sec. 8 from Article V, defines the editor's role and requires the reporting necessary as a permanent Standing Committee of the Board of Directors.

**18. ARTICLE XIII – GOLDEN GARDENS** (page 135)

Sec. 5. Changes in advertising rates shall be recommended by the editor **to the executive committee** and ratified by the board of directors.

Rationale: Establishes communication from editor to Executive Committee to board of directors.

Chairmen & Team Reports: Julie West introduced the chairmen and team leaders who reported. (See Attachment F)

Beverly Switzer, Youth Awards and Administrative Chairman, moved to ratify ten new youth clubs with 712 new Junior Gardeners. **PASSED.** (See Attachment G)

Mary Lou Goodwin, Landscape Design Council, moved that her full report be included in the minutes. **PASSED.** (See Attachment H)

President Lucas recessed the meeting at 5:26 p.m.

Changes to the Standing Rules which were approved at WB 2009:

- S.R. 70. Clarifies the roster information to be sent by the Membership Chairman by July 1.
- S.R. 74. Clarifies that APSs are not eligible to participate in the IRS Group Exemption program because they are members of permanent statewide and/or national societies.
- S.R. 76. Clarifies benefits of qualifying clubs.

The full text of these Standing Rules are in the minutes of the WB 2010 and are posted on the CGCI website.

A total of 18 amendments to CGCI Bylaws were considered at WB 2010 and recommended for adoption by the Membership at Convention 2010. Ten are classified as housekeeping and other matters and 8 deal with the position of Golden Garden editor. Check your agenda packet carefully as these will be before you for consideration at this meeting.

Please send any leads to this Chairman so that a membership packet that includes a cover letter, Benefits of Membership list and Membership Application form can be sent to potential candidates. More than 270 were mailed since September of 2009.

## Charter of the California Garden Clubs, Inc. Scholarship Endowment Fund

### Section I. Name

The Board of Directors of California Garden Clubs, Inc. (CGCI) has established the CGCI Scholarship Endowment Fund, which shall be known as the CGCI Scholarship Endowment Fund.

### Section II. Purpose

The purposes of the Scholarship Endowment Fund are:

- 1) To further augment the objectives and purposes of CGCI scholarships by providing a suitable ~~receipt~~ fund for receipt of donations, where the intent of the donor is to make a lasting contribution to CGCI scholarships to secure a sound financial base,
- 2) To provide a fund, the income from which may be allocated to the CGCI annual budget in the fiscal year following the fiscal year in which it is earned, to grant scholarships defined by the Board of Directors, and
- 3) To provide financial resources for CGCI scholarships in the event of a financial crisis (determined as provided below in IV 5).

### Section III. Endowment Committee

- 1) The Board of Directors shall establish the Board of Trustees as the Endowment Fund Committee (the "Endowment Committee") with responsibility and authority to administer and manage the assets of the Scholarship Endowment Fund under general guidelines established by the Board of Directors. This program and these monies shall, however, remain the responsibility of the Board of Directors, which responsibility may be delegated to the Board of Trustees to the extent the Board of Directors determines.
- 2) **Appointment and Term of Office.** The Endowment Committee members shall be appointed for and serve terms synchronous with the provisions for the Board of Trustees existing in the CGCI Bylaws.

### Section IV. Finances

- 1) The fiscal year of the Scholarship Endowment Fund shall be the same as that of CGCI, July 1 to June 30.
- 2) On behalf of the Scholarship Endowment Fund, CGCI may receive donations from members, nonmembers, organizations, and the General Fund. The Endowment Committee or the CGCI Board of Directors may reject any donation to the Scholarship Endowment Fund if the conditions of the gift are not in the best interest of CGCI.
- 3) The Endowment Committee shall meet as needed to determine whether or not to use the income of the fund to grant scholarships.
- 4) The initial charter is that the Scholarship Endowment Fund finance two, \$2,000 scholarships (totaling \$4,000), entirely from each year's income, if possible. As income levels warrant, additional scholarships and/or scholarship amounts may be provided. If income available for scholarships in the preceding fiscal year is insufficient to fund the planned scholarships, the Endowment Committee may vote to:
  - a. Reduce approved scholarship(s) to the amount of income available, or
  - b. Request supplemental funding from the CGCI Board of Directors to provide the minimum level of scholarships. Approved funds would come from the CGCI General Fund.
- 5) The principal (the then current total value, as of the beginning of the fiscal year, but excluding the income earned and donations received in the previous year (which are available for scholarship awards)) of the Scholarship Endowment Fund shall remain inviolate except under the following conditions:

- a. The Board of Trustees determines by unanimous vote that the CGCI Scholarship Endowment Fund is operating in a financial crisis. Such a vote may be cast in absentia by phone, e-mail, or fax. Votes by phone must be verified by two members of the Board of Trustees.
  - b. The amount distributed shall not exceed 25% of the then current total value of the Scholarship Endowment Fund.
  - c. Such an emergency distribution cannot be made more frequently than annually.
- 6) Investments shall be of the conservative type. Principal Financial Group of San Diego shall manage the investments until such time as the Trustees determine that a different management firm shall be used.

#### **Section V. Procedures of the Board of Trustees**

- 1) **Voting.** All matters requiring a decision of the Board of Trustees shall be decided by a majority vote.
- 2) **Meetings.** The Board shall meet at least 3 times each year at CGCI Board meetings. Their meetings shall be announced to the Board of Directors. The Secretary shall be responsible for recording the minutes of all meetings. A copy of the minutes shall be maintained.
- 3) **Quorum.** Four Members shall constitute a quorum for the transaction of business.
- 4) **Accepting Funds.** All funds accepted by the Endowment Committee shall be presented to the CGCI Treasurer for deposit. The Treasurer shall ~~is~~ be directed to keep separate accounts as needed for each endowment fund. The Treasurer shall advise the Secretary of the Endowment Committee of donations, but may commingle such funds for the purpose of investment and banking. The CGCI Treasurer shall transfer, as practicable, all donations and income to the Scholarship Endowment Fund, at least once annually.
- 5) **Reports.** The Board of Trustees shall keep books of account showing all transactions relating to the Scholarship Endowment Fund and shall make a written report to the Board of Directors to be presented at its annual meeting. They shall make any other reports as may be requested by the Board of Directors.
- 6) **Maintenance of Records.** Adequate records shall be maintained and kept by the Secretary of the Board of Trustees detailing the dates on which assets were received by the CGCI Treasurer, the nature of these assets, and the donors (unless anonymity has been requested by the donor), and any terms agreed to at the time of their acceptance.

#### **Section VI. Dissolution.**

In the event of the dissolution of CGCI, all Scholarship Endowment Fund assets shall be distributed to like 501(c)(3) organization(s). The provisions regarding CGCI dissolution shall be considered in making this determination.

#### **Section VII. Amendments.**

This charter may be amended from time to time, at any annual or special meeting of the Board of Directors at which a quorum is present, by a majority vote. No amendments may remove the purpose of the Scholarship Endowment Fund: to finance scholarships.

## Charter of the California Garden Clubs, Inc. Planned Giving Endowment Fund

### Section I. Name and Administration

The Board of Directors of California Garden Clubs, Inc. (CGCI) has established the CGCI Planned Giving Endowment Fund, which shall be known as the CGCI Planned Giving Endowment Fund. The Board of Directors of CGCI retains the ultimate right to maintain and administer said fund.

### Section II. Purpose

The purposes of the Planned Giving Endowment Fund are:

- 4) To further augment the objectives and purposes of CGCI by providing a suitable ~~receiptable~~ fund for receipt of donations, where the intent of the donor is to make a lasting contribution to CGCI to secure a sound financial base,
- 5) To provide a fund, the income from which may be allocated to the CGCI annual general fund budget in the fiscal year following the fiscal year in which it is earned, to meet expenses of CGCI as defined by the Board of Directors, and
- 6) To provide financial resources for CGCI in the event of a financial crisis (determined as provided below in IV 4).

### Section III. Endowment Committee

- 1) The Board of Directors shall establish the Board of Trustees as the Endowment Fund Committee (the "Endowment Committee") with responsibility and authority to administer and manage the assets of the Planned Giving Endowment Fund under the general guidelines established by the Board of Directors. This program and these monies shall, however, remain the responsibility of the Board of Directors, which responsibility may be delegated to the Board of Trustees to the extent the Board of Directors determines.
- 2) **Appointment and Term of Office.** The Endowment Committee members shall be appointed for and serve terms synchronous with the provisions for the Board of Trustees existing in the CGCI Bylaws.

### Section IV. Finances

- 7) The fiscal year of the Endowment Fund shall be the same as that of CGCI, July 1 to June 30.
- 8) On behalf of the Planned Giving Endowment Fund, CGCI may receive donations from members, nonmembers, organizations, and the General Fund. The Endowment Committee or the CGCI Board of Directors may reject any donation to the Planned Giving Endowment Fund if the conditions of the gift are not in the best interest of CGCI.
- 9) The Endowment Committee shall meet as needed to consider requests for using the income of the fund to meet expenses, as provided in Section 4. The Endowment Committee shall make its recommendations to the Executive Committee of CGCI. The Executive Committee shall decide whether to implement the recommendations, subject to ratification by the CGCI Board of Directors as deemed necessary. In the event that the Executive Committee declines to recommend an Endowment Committee recommendation, the Endowment Committee, if in 100% agreement, may take a recommendation directly to the Board of Directors for consideration.
- 10) The principal (the then current total value, as of the beginning of the fiscal year) of the Planned Giving Endowment Fund shall remain inviolate except under the following conditions:
  - a. The Endowment Committee determines by unanimous vote that CGCI is operating in a financial crisis. Such a vote may be cast in absentia by phone, e-mail, or fax. Votes by phone must be verified by two members of the Board of Trustees.

- b. The amount distributed shall not exceed 10% of the then current total value of the Planned Giving Endowment Fund.
  - c. Such an emergency distribution cannot be made more frequently than annually.
- 11) Investments shall be of the conservative type. Principal Financial Group of San Diego shall manage the investments until such time as the Trustees determine that a different management firm shall be used.

#### **Section V. Procedures of the Board of Trustees**

- 7) **Voting.** All matters requiring a decision of the Board of Trustees shall be decided by a majority vote.
- 8) **Meetings.** The Board shall meet at least 3 times each year at CGCI Board meetings. Their meetings shall be announced to the Board of Directors. The Secretary shall be responsible for recording the minutes of all meetings. A copy of the minutes shall be maintained.
- 9) **Quorum.** Four Members shall constitute a quorum for the transaction of business.
- 10) **Accepting Funds.** All funds accepted by the Endowment Committee shall be presented to the CGCI Treasurer for deposit. The Treasurer is shall be directed to keep separate accounts as needed for each endowment fund. The Treasurer shall advise the Secretary of the Endowment Committee of donations, but may commingle such funds for the purpose of investment and banking. The CGCI Treasurer shall transfer, as practicable, all donations and income to the Planned Giving Endowment Fund, at least once annually.
- 11) **Reports.** The Board of Trustees shall keep books of account showing all transactions relating to the Scholarship Endowment Fund and shall make a written report to the Board of Directors to be presented at its annual meeting. They shall make any other reports as may be requested by the Board of Directors.
- 12) **Maintenance of Records.** Adequate records shall be maintained and kept by the Secretary of the Board of Trustees detailing the dates on which assets were received by the CGCI Treasurer, the nature of these assets, and the donors (unless anonymity has been requested by the donor), and any terms agreed to at the time of their acceptance.

#### **Section VI. Dissolution.**

In the event of the dissolution of CGCI, all Planned Giving Endowment Fund assets shall be distributed to like 501(c)(3) organization(s). The provisions regarding CGCI dissolution shall be considered in making this determination.

#### **Section VII. Amendments.**

This charter may be amended from time to time, at any annual or special meeting of the Board of Directors at which a quorum is present, by a majority vote.

## District Director Reports

**Bay Bridges, Gerry Mellen:** We lost 2 clubs in the last year primarily due to the age of the members. We have cut the number of meetings to twice a year and by not having fundraisers, at least for a few years, we have been able to hold the District together and we are surviving. At our September meeting we pass out information collected from State Meeting. We have passed out a short Parliamentary Procedure packet as well as one suggesting proper procedures for a Nominating Committee. In April we distribute the District Awards to our clubs and we award 2 Scholarships. We allow smaller clubs to donate to the District Fund, thereby allowing them to contribute to the scholarship process. A few of our clubs have been very involved in their community. Friends of Heirloom Flowers takes care of the grounds of the Shinn Historical Park and Arboretum in Fremont. Pinole Garden Club, El Cerrito and several other clubs propagate plants for their annual plant sales and San Leandro Garden Club has helped clean up the grounds for George Mark Home, which is the only one of its' kind in the U.S. to assist children in their final days and for their parents when they just need a respite from being caregivers.

**Bay Ocean, Nancy McDougal:** As size, meeting times & activities of Bay Ocean District clubs vary, so do the activities. Two clubs have annual garden tours—one of its neighborhood & the other of estate gardens. There are garage sales, luncheons & fair entries for fundraising. Community outreach includes floral decorations for healthcare facilities & community buildings and care of a historical garden. This year we are also assembling a list of local speakers & tour sites to assist clubs in obtaining interesting programs for meetings. Each club focuses on the aspects of gardening which most interest their members, bringing variety to our efforts.

**Cascade, Anne Capes:** Recently this director was invited to speak to one of the district garden clubs about garden therapy and how it fits into the programs planned by the clubs. As an example, she mentioned that Anderson Valley Garden Club decided to discontinue making tray favors for the residents of the local rehab center and to replace that activity with helping residents make (hands-on experience) floral arrangements on a monthly basis. Club volunteers donate containers, flowers, greens and time. The residents gradually improved their designs so that when it was time for the annual flower show the decision was made to enter designs from this group. There were a dozen entries and about a third merited an award from flower show judges. This Director is very proud of the kind hearts in Cascade District that are moved to spread cheer with a smile and beautiful flowers. Outstanding events: 2 Blue Star Markers dedicated and 1 Landscape Design Award.

**Costa Verde, Ruth Brooker:** Our clubs engage in many activities that CGCI encourages. Members have met with Alexis Slafer to plan a Landscape School to begin in the fall of 2010 and go until the fall of 2011. Several clubs participate in youth gardening clubs; San Pedro has two clubs and is planning a third. Most of our clubs give recognition to outstanding neighborhood gardens. At this time three clubs are having plant sales in public area. They are spreading the word about their clubs and making a good amount of money for club activities, scholarships and contributions to environmental projects.

**Desert Empire, Joanne Latimer:** Our district is proud of our membership increase. We have added 22 new members in the last year – we have soared from 100 to 122. This is a wonderful percentage of increase for our small district. We feel that the more we become involved with community activities, the more membership numbers increase. Oasis Garden Club has begun working with a local Girl Scout troop. After their twice-a-year plant sale, the Girl Scouts come in to move any unsold plants back to the compound area. This has become a community project for the Girl Scouts and gives a much-needed rest to the club members. The troop receives a monetary donation, and the girls are asked to choose a plant to take home to plant in their yard. A win-win situation for both groups. Desert Rose Garden Club has been working on a landscaping and planting project in the median in their town. This will be the fifth year that they have been involved with this. Large boulders are part of the ½ mile long design this year. Lots of work, but great results. Desert Empire has finished our memorial to a great lady that many of you know. Alice Hirsch founded seven clubs, our district, and went on to become your State President in 1974. We placed a bench with appropriate plaque on a walking path in Ridgecrest. Maryanne Lucas was able to attend the dedication, along with Robin Pokorski and the presidents of all 4 of our district clubs.

**Diablo Foothills District, Sandy Rogers:** Diablo Foothills District enjoyed a successful year of activities and accomplishments this past year, including a plant sale which raised \$7,000.00 and a garden tour raising \$11,000.00. This allows continued education of the public about gardening, support for youth groups, community outreach, and great programs and speakers. DFD supported the San Francisco Garden Show with members staffing the California Garden Club Inc. membership table and took part in the Sacramento Flower and Garden Show by hosting a bus tour to the show. DFD hosted CGCI State President, Maryanne Lucas in February and CGCI Insurance Chairman Gloria Aminian during our May meeting. State awards were presented to DFD members during this convention, including Life Time Achievement, Circle of Poppies, Award of Merit, Sweepstakes Award, several Blue Ribbon Certificates of Achievement and Smoky Bear Poster Youth award.

**Golden Foothills, Sue Bennett:** Over \$8,000.00 for scholarships or local community garden projects was donated. A Standard Flower Show included Youth K-5. A club is teaching youth floral design. The Donner Garden Club of Auburn sponsored the "Garden for the Blind." The Colfax Garden Club members took created a community garden. District hosted Gardening Study School, Course II. Worked hard at the CA State Flower & Garden Show in Sacramento - for the **Kids Growing Strong, Presidents Project**. We help kids with hands on activities and ran a bookstore.

**Humboldt, Pat Chaney:** Our six clubs have had a busy spring and look forward to an even busier summer. **Eureka Sequoia Garden Club** held two plant sales in order to fund raise for the District garden project at a County Animal Control Center and for the American Cancer Society. They planted and placed hanging baskets in Eureka Old Town. They provide flower-arranging classes to encourage district members to participate in both local fairs. They have been presented with a Proclamation from the Humboldt County Board of Supervisors in recognition of National Gardening Week. **Fortuna Garden Club** raised funds to support its Annual Daffodil Show. New this year is the plant exchange and the flower and garden photo contest. They are currently working to hang baskets along Main Street to beautify downtown Fortuna. They will hold a garden tour and BBQ in June followed in July with a mystery garden tour. **The Ferndale Garden Club** is preparing to reinstate the Gala Event for



flowers and art at the fair. The city of Ferndale hosts the County Fair. In addition, they are planning to hold a summer mystery garden tour. This fall they will participate in the Ferndale Fall Market to fund raise for local beautification projects and scholarships. **Patrick's Point Garden Club** held the 4<sup>th</sup> Annual Garden Event. There were 7 speakers, a garden tour, a talk at the local Art Gallery and 40 vendors. In June the club plans to visit Fieldbrook Winery, last year's District winner of the CCGI landscape prize. **Southern Humboldt Garden Club** just held its 59<sup>th</sup> Annual Small Standard Flower Show. They award two scholarships with proceeds from this event. During summer they plan to visit each other's gardens. Busy members make for successful garden Clubs.

**Luther Burbank, Bev Davies:** Our district's project, residential Sierra Youth Center, is in its second season with their vegetable garden. Electricity provided to the greenhouse has enabled the teen girls to propagate seeds early. They hope to sell, to the public, produce boxes' filled with their garden harvest. Men's Garden Club of Santa Rosa have been working with high school agricultural students in propagating flowers and vegetables for the Club's plant sales and their landscape entry at this year's County Fair. Petaluma Garden Club held its successful biennial flower show at the Valley Vista Elementary School with students participating in the show. Santa Rosa Garden Club' fundraiser had renowned author, Elizabeth Murray, speak of her living and working on Claude Monet's Giverny area Gardens. Overseeing the Town Green Community Garden, Windsor Garden Club has installed irrigation lines, storage shed, and solar panels. Eighty redwood garden plots are under construction, and over half have been rented.

**Mendo-Lake, GinaBelle Smith:** 6 Clubs approx. 330 members. Ukiah, Willits, North Lake, Clear Lake Trowel & Trellis, Potter Valley and Fort Bragg. Average 45 attendees at District meetings. These clubs already do great things and are successful. District focus will be on attitude, communication and participation through workshop type meetings; enthusiasm that will be contagious. No programs so that time is spent connecting, exchanging ideas, sharing experiences and communicating goals and objectives. More acknowledgment of each other at every meeting. Attendance will result in a stronger connection and understanding of membership to CGCI - Because if you don't know, you can't grow!

**Palms to Pines, Linda and Ron Lang:** We stand at 16 clubs. All are active and involved in their communities. Flower shows have been held in Redlands by the RHIS Garden Club and the Riverside San Bernardino Orchid Society. RSBOS orchid society helped host the Southland Orchid Show, Moreno Valley has an in house Flower Show, Riverside Flower Show Committee had a great show, Gates Cactus & Succulent Society and Granite Hills Garden Club participated in the Cactus and Succulent Show and "A" Garden Club of Big Bear worked with The Community Flower Show. The clubs are involved in civic projects, school gardens, floral designs for the Veterans, and we have new judges about to complete the course on Flower Show Judging. We welcome two new member clubs: Calimesa Community Garden Club, from Calimesa, CA and Desert Horticulture Society of Coachella Valley in the Palm Desert area. We look forward to hosting the Fall CGCI Board Meeting in Palm Springs this September and hope to see you all there.

**Palomar, Jane McKee:** District Summary: 22 clubs, 2 affiliates, 2 youth groups (over 2000 members); 6 garden tours; 6 flower shows; 1 art/floral design show; 7 plant sales; Over \$10,000 awarded in club scholarships - 1 CGCI & 1 NGC scholarship to a District student (wahoo!); 1 Blue Star Marker dedication; 1 25<sup>th</sup> anniversary and 1 50<sup>th</sup> anniversary! Ongoing District Projects: Floral Design Forum – monthly demonstration by noted floral designers; Petals for Patriots – monthly delivery of flower arrangements to Balboa Naval Hospital and the Wounded Warrior facility at Camp Pendleton.

**Roadrunner, Clara Petrosky:** In February we hosted state president Maryanne Lucas. The luncheon theme was a celebration of Earth Day. Earth colors and accessories made of recyclable materials were used on the tables. A tour of the Luzerne Valley High School Youth Program concluded our day. We were introduced to their greenhouses, installing of irrigation systems, landscape design, pruning and building lawn furniture. All attendees went home with a daffodil bulb that was planted and cared for by the students. March found our gardens uprooted in preparation for the High Desert Home & Garden Show. Children activities, yard art, Mother's Day arrangements and ample native plants were available for the public. It was a great opportunity to share their knowledge and encourage membership. Arbor Day was celebrated with our annual tree plantings in the communities. Our clubs continue to dedicate their resources to Penny Pines, Kids Growing Strong, scholarships and charitable community organizations. Roadrunner District boasts 4 Smokey Bear Poster winners. As the year comes to an end there will be installation of officers, luncheons and a field trip to the Lavendar Festival in Cherry Valley in celebration of National Garden Week. A final District meeting hosting Jane Troutman as guest speaker will bring my first year as Director to a close. On the horizon we have a fall standard flower show and a spring garden tour.

**San Fernando Valley, Mary Waddington-Merritt:** The San Fernando Valley District was proud to receive a CGCI Landscape Design Award at the June 2010 State Convention for the 1847 Historic Gardens at Campo de Cahuenga...our Director's Project. Campo is the site of the signing of the Treaty of Cahuenga, which ended the U.S./Mexican territorial conflict and paved the way for the culmination of the Doctrine of Manifest Destiny..."from sea to shining sea." These projects were facilitated by a Principal Financial Group \$2,000 grant and a CGCI grant. A Blue Star Memorial Highway Marker completes the landscaping and is our gift to the community. Guy Weddington McCreary, Campo Chairman of the Board, accepted the award. The San Fernando Valley **"Where Excitement Is Growing"!!!**

**Santa Clara Valley, Sara White:** San Jose Garden Club is forming a group to maintain a public strip of land, planted with roses, in South San Jose. Landscape Design Consultants Dorothy Doremus and Eva Mae Heimans, of Las Jardineras Garden Club, presented a CGCI Landscape Design award to the Guadalupe River Park Conservancy, an award-winning, 254-acre park of trails, water features and playground areas – one of the first downtown parks in the U.S. to include flood protection with the river's sensitive ecology. At that same meeting in May, a CGCI presidential citation was given to outgoing president Dorothy Doremus who began her landscape design studies over 50 years ago in Rutgers, NJ. Carmel Valley Garden Assoc. had their annual May flower and art show where nearly 4,000 people attended. A Saturday night gala, the children's garden with educational activities for young and old, a silent auction, a judged flower show, and better organization all contributed to their tripling their profits. An educational project will be financed with the proceeds. One of South Valley Fleurs' best programs was a speaker from the National Audubon Society after which members ordered bluebird nesting boxes, put them together and installed them in their back yards. Four clubs participated in the San Francisco Flower & Garden Show ticket sales fundraiser netting approximately \$300. The district is

now inviting all of our clubs to participate in an educational grant program whereby \$1,750 will be distributed based on the acceptance of proposals received. This money was received from the estate of Arleen Chasson, former member of Furyu Floral Designers, who died five years ago and this was the best way we could think of to honor her memory.

**Sequoia Foothills, Carolyn Villi:** I took time between our March and June District Meeting to visit about half of our Sequoia Foothills District's garden clubs. All our District member clubs are doing a wonderful job of furthering the interest of CGCI. Garden tours, plant sales, scholarships, youth workshops, flower show, work parties, landscaping of Veteran Memorial Gardens, plant exchanges, children's gardens, they're busy doing it all. During my visits what I noticed the most is how our manners and protocol are failing. I'm considering having a special meeting with our District Presidents to help them with visitor protocol and conducting proper business meetings.

**Valley Lode, Chelsea Wilson:** Clubs 18 – Members 1392; 3 district meetings per year. Increase in communication. Continue district newsletter quarterly, on-line. Tuolumne Co. Garden Club started a website, [www.tcgclub.com](http://www.tcgclub.com) "Multi-media" group of Modesto Garden Club has traveled to other clubs to give presentation; and contributed photos for City of Modesto's "water-wise gardening guide". At May 4<sup>th</sup> district meeting, in collaboration w/ CGCI's LD Council, held ceremony to honor the owner & the gardener of Wine & Roses hotel/restaurant/spa in Lodi.

**Yosemite Gateway, Suzy Walker:** Merced Garden Club held programs on honeybees, growing herbs for cooking, creating festive garlands and orchids. Butterfly Garden Club of Mariposa held programs on winter gardening and indigenous butterflies and their habitats, and a field trip to Flower Farm. Le Grand Garden Club has grown not only membership but in knowledge and ideas. They now have 51 active members, 14 associate members and 6 lifetime members. They held programs on planting for spring blooming and iris garden cultural practices. Cathy's Valley Garden Club lost their mentally challenged group due to government cuts. They continue ongoing maintenance of Cathy's Valley Cemetery and met with Master Gardener Noma Moore and their group for a workshop. Atwater Garden Club held a holiday craft day, an annual rose pruning workshop, and programs on bugs and camellias.

### CCGI Committee Chairmen and Team Reports

**Arbor Day, Lorraine Ornelas:** Many clubs throughout the state have participated in celebrating Arbor Day by planting trees or making donations to various organizations related to land conservancy. San Pedro Garden Club celebrated two events: the first was the planting of a tree at the Harbor Retirement Center and another at Seventh St. School in memory of longtime member Jessie Varalay. Hermosa Garden Club, Riviera Garden Club, Long Beach Garden Club, and Naples Island Garden Club also held ceremonies/donations. Naples Island Garden Club will be planting a cypress tree at a later date by the Parks and Recreation Department and a memorial service was held on March 16, 2010 at Mother's Beach. This chairman is preparing a book to be presented to President Maryanne Lucas at the 2011 convention. It is not too late to make me aware of your ceremonies or send pictures/newspaper clippings.

**Backyard Habitat, Margaret Strachan:** This chairman has remained in contact with representatives from the National Wildlife Federation and the North American Butterfly Association. They have supplied materials that I have been able to use as part of a wildlife backyard habitat exhibit at the 2010 convention. The exhibit features the requirements of a backyard habitat and several other items of interest. Four Golden Garden articles have been written during the year, and a brochure should be ready by the fall board.

**Blue Star Memorial Markers – Southern California, George Unrine:** Six markers were dedicated during the 2009-2010 CGCI year. Two were placed in national cemeteries. This chairman was pleased to participate in a dedication by the Los Angeles GC and Brentwood Glen GC at California's oldest national cemetery, the Los Angeles National Cemetery on November 6, and then travel to California's newest national cemetery, the Sacramento Valley National Cemetery, for a dedication by Vaca Valley GC on November 7. Of eight national cemeteries in California, five now have memorial markers. Coming up is a memorial marker at the Ft. Rosecrans National Cemetery that will be dedicated by Point Loma GC on June 26. This chairman would also like to remind the garden clubs and districts that the Blue Star Memorial Fund still exists. It can provide grants to help in the acquisition of markers as well as to refurbish markers. The monies come from donations by clubs and districts in support of the Blue Star Project.

#### **Board of Trustees, Robert Gordon:**

The restricted funds have been resolved and the results given to the Financial Secretary so the Financial Secretary has a current authority for writing checks from those accounts.

Two Charters for Endowments were presented to the Convention for adoption. One endowment for scholarships and one endowment for planned giving. Copies of the Charters are attached to these minutes.

The endowments were opened for charter membership beginning at this convention and ending at the 2011 convention. Anyone donating to either endowment during that period will be listed as a charter member of the endowments in perpetuity. Giving levels are: Copper \$500, Bronze \$1,000, Silver \$1,500, Gold \$2,000 and Platinum \$2,500. Benefactor \$30,000. Three checks were received at this convention. 1. Garden Study Club of the Peninsula 2. Southern California Garden Club 3. Kathryn Biggins. A protocol for processing these checks is being developed.

June 3 and 4, 2011 will be a "thank you" celebration in San Luis Obispo. Friday evening will be a champagne/dessert reception, Saturday morning a tour of the "Leaning Pine Arboretum", Lunch in the Gardens of the Historic Jack House amongst the Montana De Oro District Standard Flower Show, late afternoon cash bar and hors d'ouvres at the Madonna Inn. These events will be free to those who donate \$500 to either endowment during the charter period.

The Trustees decided to transfer \$55,000 from the Scholarship Fund to the Principle Finance Scholarship Endowment when a CD matures in July 2011

The Trustees elected the following officers to serve the 2010-2011 term. Chair of Trustees, Joan Craig, Secretary of Trustees David West, Chair of the Endowment Committee Bob Gordon and Secretary of the Endowment Committee David West.

**Budget & Finance, Joelle Holford:** Errors were found in the two reviewed financial reports ending 6/30/2009 prepared by John Rettig, CPA. The corrected financial reports have now been received. They have been accepted and are available for review, if requested under standard CGCI guidelines. Mr. Rettig has closed his business. As a result, CGCI needs to hire a new accounting firm. The Budget and Finance Committee along with the Executive Committee and Board of Trustees recommend Carolyn Mayes, CPA be hired to do CGCI's informational tax returns and reviewed financial statements. The Board of Trustees has provided updated guidelines for Restricted Funds that will be implemented. The 2010-2011 Budget will be presented at the organizational meeting June 7, 2010.

**California Native & Invasive Plants, Donna Thomas:** Three nonnative grasses have rapidly become major threats in many parts of the state. These are: (1) Giant Reed (*Arundo donax*); (2) Pampas grass and Jubata grass (*Cortaderia selloana* and *Cortaderia jubata*); and (3) Fountain grass (*Pennisetum setaceum*). California native perennial warm season bunchgrasses can be alternatives to the nonnative grasses - such as Indian Ricegrass (*Achnatherum hymenoides*), Deergrass (*Muhlenbergia rigens*), and Alkali sacaton (*Sporobolus airoides*). Remember that they do produce lots of seeds and do reseed. Keep them under control and rejuvenated by mowing or shearing the plants in the fall or winter and water them conservatively. This chairman has prepared an article about each of these three native bunchgrasses. District Directors will find them attached to the copy of this Chairman's report in their folders.

**Climate Change, Dwight Holford:** Climate change is in the news constantly. We are constantly reminded of its presence in our day to day lives. How do we know that these reports about climate change are valid? One suggestion is to see if the report is backed up by a proper scientific study. A scientific study has some of the following features: an abstract, usually a short paragraph on the subject; the body of the report discussing the problem along with citations for each reference; conclusions, if any, possibly a summary and recommendations, if warranted; finally, a major study will have survived peer review and will have been published in an established scientific journal. Using the search engine of your computer will reveal thousands of references on climate change. Some do not support the idea that climate change is real. One major source of information is the US EPA, which continues to place great effort into this study. National Geographic is another good source. Scientific journals and think tanks are other sources of information. In all, there is reliable information out there for a person to make reasoned judgments in your decisions of just what climate change means to you and what course of action is appropriate.

**Educational Schools Finances, Mary-Jo Noth:** This year the only new Educational School, the Gardening Study School in Loomis, has been self-financing. Therefore, a financial report to CGCI was not mandatory. At the 2010 CGCI Convention the Board of Directors approved the "Updated Restricted Funds List" recommended by the Board of Trustees. This list specifies the amount of grant funding for each course in an Educational School. An Environmental Studies, Flower Show, Gardening Study, or Landscape Design School local chairman may request funds for each course by submitting the budget for that course to the CGCI Educational Schools Finance Chairman. The intent of the grant program is to reduce the costs to participants.

**Environmental Studies School, Shane Loooper:** On November 9-10, 2010- Bay Ocean District will continue (Finally) with the Bay O Series of Environmental Studies School with Course 3. Brochures are available at this convention. See the schools display in the Exhibit Room. Your club or district can sponsor an environmental school without cost your club or district money. Talk to this chairman about how this is possible.

**Gardening Consultants Council, Myrtle Findley:** The Council presented certificates at Convention to two local gardeners, also Awarded HT-1 Horticulture Award to a winner. This Council has blank Certificates on the Website for local Clubs and Districts to download and use locally. We urge Clubs and Districts to acknowledge great Gardens and outstanding Horticulture achievements in their own areas. We are gardeners, let's honor those outstanding gardens!

**Gardening Study Schools (GSS), Greg Pokorski:** Course II, Series 21, sponsored by Golden Foothills District in Loomis, took place April 20 & 21. Fourteen attended and thirteen tested. Accreditation processing has been completed. Course III will be September 21 & 22 - registration information/brochure has been placed in the District Director mail boxes. Annual reminders regarding eligibility to refresh were sent to all Consultants. Eleven Gardening Consultants refreshed at this convention. Two refreshed at the NGC Atlanta Convention Tri-Refresher. Several have refreshed by taking NGC Online Course I. The NGC board voted in Atlanta to terminate NGC's contract with Learn2Grow. The Online Course is defunct as of 6/3/10. A trifold soliciting interest in sponsoring a school was created and copies have been placed in the District Director mail boxes. This chairman would like a new school ready to go soon after April, 2011 when the Loomis series will conclude.

**Home Grown, Myrtle Findley:** This chairman urges members to grow produce at home. Home Grown has been coined as "locavore". Many cafes and restaurants are now serving this type of food. Let's as gardeners learn more about it. Be creative, think up your own kind of original dish then enter the Green Recipe Contest.

**Honor Book, Cathy Biggins:** There were ten donations to the Honor Book fund in the past year totaling \$575. Twelve individuals were recognized, including two memorials. Cards of acknowledgment were sent to all donors and recipients or family. The Honor Books were on display in the exhibit room at Convention.

**Horticulture, Jim Bathgate:** Among the flowers displayed at the CGCI 2010 convention were *Calandrinia grandiflora* which we noticed at the San Diego County Fair and were subsequently given some cuttings. We have been successful with propagating them. The plants are drought

tolerant, gradually spreading and producing 2 foot tall stalks with magenta flowers. They have survived 22 degree temperatures in Valley Center. Other flowers were *Ornithogalum arabicum* (white) and *Ornithogalum dubium* (orange and yellow). These are bulb plants and blossom for six weeks or longer on one foot tall stalks. They like to have a dry rest period following the bloom.

**IRS Nonprofit Group Exemption, Chuck Goodwin:** The following 5 Clubs have been certified to participate in the CGCI IRS Nonprofit Group Exemption program and are ready to be ratified: Calimesa Community Garden, Foothill Garden Club, Idyllwild Garden Club, San Clemente Garden Club, San Jose Garden Club. This brings to 121 Districts, Clubs and Affiliates who are participating in this benefit of CGCI membership. For other clubs interested in the Group Exemption program, information is available on the CGCI website under the Club Service tab or the Club Support box. An easy way to identify those clubs and districts that are part of the 501(c)(3) Group Exemption program is to go the CGCI website. Roll over "Club Services" then "501(c)(3) Group Exemption" and click on 501(c)(3) clubs. For all Clubs who participate in the CGCI Nonprofit program, you must file the IRS Form 990-N (Electronic Postcard) after the close of your fiscal year, which is June 30, 2010, and is delinquent 5 ½ months after the close of the fiscal year, which is November 15, 2010. While there are no penalties for late filing, if you have not filed the last two years the IRS will revoke your nonprofit status after November 15, 2010. For those clubs who are incorporated, a reminder of the biennial filing with the California Secretary of State of the Statement of Information (Form SI-100).

**Landscape Design Study Program, Alexis Slafer:** A Landscape Design Study Program is planned for Southern California: Series 24, Courses 1 - 4. Sponsored by Costa Verde District and scheduled to take place at the South Coast Botanic Garden, Palos Verdes Peninsula. The full course will be completed within one year. Encourage your clubs and districts to sponsor the next school. Look for handouts about the Landscape Design Study Program in your mailbox. Reporting as Chair for this Convention's Tri-Refresher (open to all Convention attendees) – over 20 consultants are refreshing.

**Legislation/Government, Chuck Goodwin:** STATE PARKS UPDATE - At 2009FB this chairman reported that as many as 100 of the more than 270 park units in California faced closure because of a cut in general fund revenue of over \$14 million. The final impact for the year was that most parks had reduced services, mostly through reduced days of operation or seasonal closure. No parks were permanently closed. At 2010WB the CGCI board of directors adopted a position paper "Support(ing) the Preservation and Maintenance of California State Parks." The State Parks Foundation circulated a petition to create a permanent funding source for parks. Signatures were submitted to the Secretary of State for verification in May. If it qualifies, it will be on the November, 2010, general election ballot and if passed, will add an \$18 surcharge to vehicle registrations, raising an estimated \$500 million annually, of which 85% will go to park support. In exchange, motorists would no longer be charged a day use fee to use state parks.

**Member Award of Distinction Program, Mary-Jo Noth:** Publicity for this program has been on-going: in CGCI e-newsletters, on the CGCI website, in an article with illustrations on page 5 of the April-May 2010 Golden Gardens, and with an exhibit at the 2010 CGCI Convention. It is hoped that all this will encourage more clubs and districts to honor their members who serve their clubs and communities with distinction.

#### **NGC Schools Team, Greg Pokorski:**

This team supports the administration of these NGC Educational Programs: Environmental Studies Schools, Gardening Study Schools and Landscape Design Schools, and is comprised of Schools Chairmen (Shane Looper – ESS, Greg Pokorski – GSS, Alexis Slafer – LDSP), Council Chairmen (Myrtle Findley – Gardening Consultants Council, Mary Lou Goodwin – Landscape Design Council), Mary-Jo Noth – Educational Schools Finance Chairman, and Robert Schuler – ESS and LD School Credentials Chairman. We met on June 5.

Individual Schools and Councils reports will be made during the chairmen's reports by several team members.

Thanks to Mary Lou Goodwin Schools Exhibits were on display at the State Flower Show in April and at this convention.

Thanks to Alexis Slafer, Mary Lou Goodwin and Convention Chairs Jean Reiley and Beverly Brune for all their work in arranging, accrediting and conducting the Tri-Refresher held at this convention and for making it a success.

A Consultant who is interested in conducting an Environmental Studies Schools series in southern California visited our meeting, asked a lot of good questions, hopefully got some helpful information and illustrated an interest in and enthusiasm for the future of our educational programs.

Gardening Study Schools Refresher Certificates were presented to Pat Clayes, Joan Craig, and Jane Troutman. A Gardening Consultant Certificate was presented to Carole Lung. A Master Gardening Consultant Certificate was presented to Joan Craig.

**Program and Speaker Registry, Denise Davis, Co-chairman:** Following the Winter Board Meeting in January, letters were sent out via e-mail to the District Directors of Northern California to encourage those who had not yet sent in their information to participate. Enclosed were additional forms to distribute to the club presidents. This co-chairman proceeded to compile the information into 2 spreadsheet forms- one according to district and one according to subject. By March 1<sup>st</sup>, only 2 more clubs and one district responded. The lists were completed by the end of March. On April 8 letters were sent to the District Directors along with the completed lists.

**Propagation "Free Plants", Lee Bathgate:** Start a Propagation Group in your Garden Club. A club propagation group has many benefits including free plants, plants for plant sales and learning activities plus a social time of working together. The first concern is a place to work which may be a community area or rotating to members' homes. Soils, containers and storage are other concerns which will need to be addressed. Instruction can be from knowledgeable club members, growers in the area or colleges and master gardener members. Member's gardens are a great source of plant materials and will vary with the changes of season. Libraries are a source for reference materials. I use *The American Horticultural Society Plant Propagation* by Alan Toogood.

**Public Relations Team, Julie West:** Public Relations Team chairman Julie West met at 10:30 a.m. to discuss progress made by the various chairmen since the last board meeting. All chairmen present are in the process of preparing informational brochures pertaining to each area of expertise. Also in the works are ideas for providing bookmarks highlighting our events. Jane Berger has a brochure on bees. Information will be made available to our members through our web site. Members were encouraged to prepare "talking exhibits" for the convention to be held from May 15-19, 2011 at the DoubleTree Hotel in Rohnert Park. We were also encouraged to use the mission statement of CGCI in all of our publications and were reminded that all information has to have CGCI board approval.

**Reforestation, Judy Unrine:** CGCI has paired with the NFS on two large continuing projects. One focuses on planting seedlings. That is the venerable Penny Pines Fund. You have all heard of it and have donated large sums toward returning trees to our forests. The other continuing project is the Restoration and Reforestation Fund. Its objective is to restore, preserve and protect our public lands. Projects can be chosen anywhere throughout our state. Think about a project that might restore habitat. Forest Service workers, armed with pick and axe are removing invasive species of plants, so that native plants can be returned to the site. With the return of native plants, birds, butterflies, and small animals will return to drink at the bubbling spring and eat the seeds and berries. You can see the reason why it is important for members of CGCI to roll up your sleeves and support these very important projects. How large are the possibilities? Only you can decide by going home to your clubs and finding ways to donate to this very important fund. Donations of \$100 increments are suggested for clubs, but any amount will be accepted.

**San Francisco Flower and Garden Show, Gwen Nansen:** The San Francisco Flower and Garden Show was well represented by 17 arrangers doing 21 designs. They were from Bay Ocean, Luther Burbank and Santa Clara Valley Districts. We had a good spot, in the middle of the fire lane, with two tables with a divider in between so thirteen designs were placed on each side of the tables. The new owners stopped by our tables often to see if they could do anything for us. The atmosphere seems to have changed for the better. They also asked if we could arrange a meeting to make plans for next year. The membership table was well represented also. Sara White had no trouble getting volunteers – they seemed to enjoy giving out information about CGCI. Rita Desilets was with us several days and passed out CGCI materials also.

**Sempervirens Fund, Rosa Radicchi:** To-date, we have collected \$8,475.00 towards Grove #10, a 2.5 acre grove. The new process for donations is working, however, the Sempervirens Fund have just completed their move to their new offices. Their new mailing address is: P. O. Box 1417, Los Altos, CA 94023-1417. Financial pressures and dangers of park closures throughout the State continue to mount. In 2009, 220 parks (80% of the entire system) were proposed for closure. Please read the Summer 2010 issue of the **Mountain Echo** newsletter. In particular, the article addressing the California State Park Crisis and their endorsement, along with many others, of the **California State Parks and Wildlife Conservation Trust Fund Act of 2010**, a measure which will be on November ballot. Plan a visit to Big Basin or a forest near you soon, and get an up-close and personal look at the beauty of our Redwood Forests!

### **LANDSCAPE DESIGN COUNCIL, Mary Lou Goodwin:**
