PROPOSED 2011 POLICY TO REPLACE CURRENT POLICY IN YEARBOOK

CORPORATE LOGO

The CGCI logo was designed by the California School of Arts and Crafts in Oakland in 1932. The Oakland Business Men's Garden Club paid for it and presented it to the Federation. The wording was changed when CGCI became incorporated in 1936 and changed from California Garden Club Federation to California Garden Clubs, Inc. The logo is used on letterheads, program, and similar materials, and as the design for the CGCI state membership pin.

AFFILIATE MEMBERSHIPS IN OTHER ORGANIZATIONS

- 1. CGCI affiliate memberships in other state, national and international organizations shall be as authorized by the board of directors upon determination that no conflict exists between the stated objectives of CGCI and the affiliate organization(s), and that membership in the affiliate organization(s) will not jeopardize CGCI's tax exempt status at any governmental level.
- 2. Dues for CGCI affiliate memberships in other organizations shall be included in the budget and paid from the General Fund when due.

AWARDS

- 1. All CGCI awards shall be made upon merit without limitation to the number won by any individual, club, associate plant society, or district.
- 2. Certain special awards shall be given only at the discretion of the awards committee, with final approval of the state president.
- 3. Winners of regional and national awards shall be announced at the state convention, provided the regional and national conventions precede the state convention.
- 4. Awards shall be presented at the convention to current district directors or their designated representative.
- 5. Entries for Pacific Region and NGC awards shall be forwarded to the proper regional and national chairmen by the CGCI awards chairman.

BLUE STAR MEMORIAL HIGHWAY & BY-WAY PROJECT

- 1. A Blue Star Memorial Fund had been established to assist clubs and districts in purchasing Blue Star Memorial markers.
- 2. Contributions or memorial donations shall be made payable to CGCI and sent to the Blue Star Memorial Chairman who shall make a cash receipt schedule in triplicate. The chairman shall keep one copy for the files, send one copy to the financial secretary, and send one copy and check(s) to the CGCI treasurer for deposit in the Blue Star Memorial Fund.
- 3. Blue Star Memorial Fund money may also be used for refurbishing existing markers.
- 4. Requests for financial assistance in completing a Blue Star Memorial marker project shall be made through the Blue Star Memorial Chairman on a CGCI application form.
- 5. Expenses of Blue Star Chairman shall be paid from the General Fund under CGCI budgeted Chairman Expenses up to \$50. Chairman expenses in excess of \$50 budgeted shall be submitted to the Executive Committee for approval and paid from the Blue Star Memorial Fund.

DISTRICTS AND DISTRICT DIRECTORS

- 1. Directors are elected in their respective districts and installed at the CGCI Convention. Qualifications for office and rules governing election shall be those adopted by the district. At the close of convention they officially take office and assume their duties as members of the CGCI Board of Directors.
- 2. Guests and/or speakers may attend the Directors Forum only upon invitation by the District Director Coordinator. (Current Policy #1)
- 3. It is recommended that directors schedule and preside at a minimum of three meetings each year following CGCI fall board, winter board and annual convention, which may include regular and special meetings, presidents' conferences, board meetings, workshops, etc.

EDUCATION: FLOWER SHOW SCHOOLS, LANDSCAPE DESIGN STUDY PROGRAMS, GARDENING STUDY SCHOOLS, AND ENVIRONMENTAL STUDIES SCHOOLS

- 1. NGC has established educational programs of study for Flower Show Schools, Landscape Design Schools, Gardening Study Schools, and Environmental Studies Schools. Any garden club member or the general public may attend the lectures upon paying registration. After successful completion of a series of courses, a student may become a flower show judge, landscape design consultant, gardening consultant, or environmental consultant accredited by NGC. A judge or consultant must belong to a member club. A flower show judge has further requirements of passing a reading exam and securing judging and exhibiting credits.
- 2. A series of four courses may be sponsored by a club, district, council, or CGCI. The sponsor shall provide the appropriate state school chairman with the proposed dates and location for the series, name of the sponsoring group, local chairman, and proposed first course budget. The state chairman will then present this information to the state president for initial approval with final approval by the state board of directors. Contact appropriate state chairman for further details.
- 3. Correspondence from all schools to NGC chairmen and to NGC headquarters must go through the respective state school chairman.

COMMITTEES

Flower Show Schools Committee

- 1. The chairman shall be the CGCI Flower Show Schools Chairman. Other members are the chairmen of Awards, Schedules, Judges Credentials, Judges Council, Symposia and any others deemed necessary.
- 2. The Flower Show Schools Chairman is responsible for the flower show school program within CGCI and for adherence to NGC requirements in all details of symposia. This chairman shall maintain the file of each flower show student and judge and shall maintain a record of all courses of a flower show school series, the Handbook examination, and symposium credits.
- 3. The Credentials Chairman will provide the CGCI Yearbook Chairman, by July 1, with a current list of student judges and all judges in good standing along with their expiration year for the current yearbook/roster of CGCI.
- 4. NGC policy shall apply to the CGCI flower show schools program, following *HANDBOOK FOR FLOWER SHOWS, FLOWER SHOW SCHOOL MANUAL, INSTRUCTOR'S MANUAL,* and directives published in *THE NATIONAL GARDENER*.
- 5. Expenses of the Flower Show Schools Chairman including Awards, Schedules, Credentials, and Symposia shall be paid from the General Fund under CGCI budgeted Chairman Expenses up to \$50 each. The Flower Show Schools Chairman expenses in excess of \$50 budgeted shall be submitted to the Executive Committee for approval and paid from the Educational Schools Fund. NOTE: Symposia chairman expenses in excess of \$50 shall be paid from the Symposium Fund upon approval from the Executive Committee.

Landscape Design Schools

- 1. The Landscape Design Schools Chairman shall: (a) keep records of all CGCI Landscape Design School students, Provisional Consultants and Landscape Design Consultants, including their refresher status; (b) answer all questions regarding Landscape Design Consultants certificates and notify Consultants when their five-year renewal will lapse; (c) provide the CGCI Yearbook Chairman, by July 1, with a current list of Provisional, Accredited and Master Landscape Design Consultants along with the expiration year of their credentials for the current yearbook/roster of CGCI.
- 2. Expenses of the Landscape Design Study Program Chairman shall be paid from the General Fund under CGCI budgeted Chairman Expenses up to \$50. Chairman expenses in excess of \$50 budgeted shall be submitted to the Executive Committee for approval and paid from the Educational Schools Fund.

Gardening Study Schools

- 1. The Gardening Study Schools Chairman shall: (a) keep records of all CGCI Gardening Study Schools students, Provisional Consultants and Gardening Consultants, including their refresher status; (b) answer all questions regarding Gardening Consultants certificates and notify Consultants when their five-year renewal will lapse; (c) provide the CGCI Yearbook Chairman, by July 1, with a current list of Provisional, Accredited and Master Gardening Consultants along with the expiration year of their credentials for the current yearbook/roster of CGCI.
- 2. Expenses of the Gardening Study Schools Chairman shall be paid from the General Fund under CGCI budgeted Chairman Expenses up to \$50. Chairman expenses in excess of \$50 budgeted shall be submitted to the Executive Committee for approval and paid from the Educational Schools Fund.

Environmental Studies Schools

1. The Environmental Studies Schools Chairman shall: (a) keep records of all CGCI Environmental Studies Schools students, Interns and Environmental Consultants, including their refresher status; (b)

answer all questions regarding Environmental Consultants certificates and notify Consultants when their five-year renewal will lapse; (c) provide the CGCI Yearbook Chairman, by July 1, with a current list of Interns, Accredited and Master Environmental Consultants along with the expiration year of their credentials for the current yearbook/roster of CGCI.

2. Expenses of the Environmental Studies Schools Chairman shall be paid from the General Fund under CGCI budgeted Chairman Expenses up to \$50. Chairman expenses in excess of \$50 budgeted shall be submitted to the Executive Committee for approval and paid from the Educational Schools Fund.

ADVANCED STUDY POGRAMS

See FINANCES for "Financial Procedure for Sponsoring State Functions" and "Grants and Loans."

Symposia, tri-refreshers/bi-refreshers, landscape design conferences, gardening study forums and environmental conferences are sponsored by CGCI for flower show judges, landscape design consultants, gardening study consultants, or environmental consultants in order that they can continue advanced study. Judges and consultants must be members in good standing of a member club and maintain a current subscription to *THE NATIONAL GARDENER*. Subscription to *GOLDEN GARDENS* and CGCI e-Newsletter is also recommended. Any garden club member or the general public may attend the lectures upon paying registration.

COUNCILS

Statewide council meetings may be held in conjunction with CGCI board meetings, Conventions and/or Symposia.

Flower Show Judges Council

- 1. To establish a new judges council, a petition shall be presented to the CGCI Executive Committee, setting forth the proposed council's objectives and signed by each proposed founding member.
- 2. The judges council hosting the Judges Council Banquet at the CGCI Convention shall be allowed to add an overage to the meal price to help defray expenses. (Current Policy #2)
- 3. Flower show judges shall not accept fees for judging flower shows sponsored by member clubs or organizations affiliated with NGC. Mileage fees may be accepted.
- 4. Membership in more than one judges council is permitted.

Landscape Design Council

- 1. Landscape Design Council membership is open to fully accredited and provisional Landscape Design Consultants upon payment of dues at the beginning of each two-year term.
- 2. The Landscape Design Council Chairman is responsible for planning and conducting meetings of the Council and for the sponsored landscape design awards.
- 3. This chairman's expenses and the sponsored landscape design awards are paid from the Landscape Design Council funds.

Gardening Consultants Council

- 1. Gardening Consultants Council membership is open to fully accredited and provisional Gardening Consultants upon payment of dues at the beginning of each two-year term.
- 2. The Gardening Consultants Council Chairman is responsible for planning and conducting meetings of the Council and for the Garden award(s).
- 3. This chairman's expenses, the garden awards and sponsored horticulture awards are paid from the Gardening Consultants Council funds.

ENDOWMENTS

In June 2010, the Board of Directors established two CGCI Endowment Funds: CGCI Scholarship Endowment Fund and CGCI Planned Giving Endowment Fund.

The Board of Trustees serves as the Endowment Committee with responsibility and authority to administer and manage the assets of both Endowment Funds under general guidelines authorized and governed by the Charters of each endowment.

Donations may be designated for deposit in one endowment fund or split between the two funds: Planned Giving and Scholarship.

- 1. The Endowment Chairman shall make a cash receipt schedule in triplicate. The chairman shall keep one copy for the files, send one copy to the financial secretary, and send one copy and check(s) to the treasurer to be deposited into the respective Endowment Fund.
- 2. The Endowment Secretary shall send acknowledgment letters to donors in accordance with IRS guidelines for all donations received.

FINANCES

GENERAL

- 1. All motions directing the expenditure of CGCI monies shall specify from which designated fund the monies shall be paid.
- 2. Printing and postage expenses for the minutes of all CGCI meetings and conventions shall be budgeted and paid from the General Fund as part of the Recording Secretary's budget.

CHAIRMEN WHO PROCESS CGCI FUNDS

- 1. Each chairman who collects money in the name of CGCI shall make a cash receipt schedule in triplicate. The chairman shall keep one copy for the files, send one copy to the financial secretary, and send one copy and check(s) to the treasurer.
- 2. Chairmen who receive funds which are to be sent directly to a project shall keep one copy for the files, send one copy to the financial secretary, and send one copy and the check(s) to the project.

Employer Identification Number (EIN) for these functions marked () have been secured and are available from the chairman.

- 1. The sponsor or host district/club may open a temporary checking account in its own name. The EIN of the sponsor or host district/club or, if necessary, a new EIN shall be used to open the checking account. Form SS4 (application form for EIN) is available from the IRS. *The CGCI EIN may not be used.*
- 2. Revenue from board meetings and conventions shall be governed as follows:
 - a. Revenue from board meetings shall be retained by the host.
 - b. Revenue from conventions shall be divided as follows:
 - Half of the net proceeds from conventions shall be placed in the General Fund and the remaining half shall be retained by the Host.
- 3. Individuals or commercial enterprises wishing to sell products or take orders at or during CGCI conventions and board meetings must be approved by the executive committee and pay an agreed upon percentage of the gross sales and/or a table fee. Revenues shall be divided equally between CGCI General Fund and the function host. (Left this in for reinforcement of SR 31)
- 4. Financial records of the convention shall be maintained under the direction of the district convention chairman and shall be audited by a qualified individual approved by the board of directors.
- 5. The financial objective of sponsoring or hosting the following state functions is to break even. If there is a gain or loss, the financial responsibility is as follows:

Gain or loss transferred to CGCI fund:

Convention (50% or half to/from General Fund)*if amendment to Article XII Sec. 5 passes

Wildflower conference - Wildflower Fund

Symposia - Symposium Fund

Landscape design conference - Educational Schools Fund

Gardening study forum - Educational Schools Fund

Environmental conference – Educational Schools Fund

Civic development conference - Educational Schools Fund

The word "sponsor" is used for schools, symposia, conferences, forums, bi-refreshers and tri-refreshers.

The word "host" is used for state board meetings and conventions.

Gain or loss remains with sponsor or host:

Convention (50% or half retained by the Host)*if amendment to Article XII Sec. 5 passes

Flower show schools

- * If a loss should occur, the sponsor or host may appeal to the executive committee for possible monetary reimbursement.
- 6. Within 90 days of the close of a function or of each course in a school series, the chairman shall send copies of the financial report as follows:

- 7. The financial outcome shall be recorded in CGCI minutes in the appropriate chairman's report.
- 8. The financial outcome of each course in educational schools will be monitored by the education schools finance chairman.
- 9. NGC examination fees for NGC school courses, handbook examinations, symposia examinations, and refresher fees shall be processed by the applicable state schools chairman. NGC fees shall be sent to NGC.

GRANTS AND LOANS

Grants

A grant of \$250 may be awarded, upon approval of proposed budget by CGCI Educational Schools Finance Chairman, to a new CGCI ratified, flower show school*, landscape design school*, gardening study school*, environmental studies school, conference or refresher to help defray costs from the Educational Schools Fund. If school, conference or refresher is profitable, grant may be returned to the fund.

*Flower show school would exclude Course 1 – see Helen Minor Fund (until depleted); gardening study school and landscape design school would exclude Course 1 – see Eleanor Miller Fund (until depleted). Grants of up to \$250 may be available if needed for courses 2, 3 or 4 of any NGC School (upon approval of proposed budget) and if school is profitable, grant(s) may be returned to the fund for future schools. (Currently Policy #3 & 4 amended to comply with new Restricted Fund Guidelines approved at Convention)

Loans

Upon approval of the board of directors, the following loans for preliminary expenses are available. (Currently Policy #5)

\$500 state convention and regional convention when CGCI is the host

\$700 Flower Show School symposium

\$250 - \$500 state board meeting, landscape design conference, gardening study forum, bi-refresher/tri-refresher, environmental conference, civic development conference, wildflower conference.

GOLDEN GARDENS

- 1. The editor shall departmentalize the work of the magazine, select all material for a balanced publication, and be responsible for assembly, printing, and mailing.
- 2. The CGCI Financial Secretary shall record all monies collected in the name of GOLDEN GARDENS, pay all bills, send all invoices, prepare financial statements to be presented to the board of directors, and submit the annual GOLDEN GARDENS budget for adoption at the organizational meeting.
- 3. Circulation Chairman shall (a) maintain database of subscriptions, (b) invoice and collect subscription fees for both 100% clubs and individuals upon expiration, and (c) process new subscriptions. This chairman shall make a cash receipt schedule in triplicate keep one copy for the files, send one copy to the CGCI Financial Secretary, and send one copy and check(s) to the treasurer.
- 4. Chairmen shall be entitled to reimbursement from the GOLDEN GARDENS account for expenses incurred in the fulfillment of duties of the office, on proof of expenditures as budgeted. The chairmen shall incur no indebtedness other than the operating expenses of the magazine without the authorization of the CGCI board of directors.
- 5. Golden Gardens Angels and Season's Greetings were established to be used to

help finance the publishing of GOLDEN GARDENS. Contributions shall be sent to the GOLDEN GARDENS Angels and/or Season's Greetings chairman who shall make a cash receipt schedule in triplicate. The chairman shall keep one copy for the files, send one copy to the GOLDEN GARDENS finance chairman, and send one copy and check(s) to the treasurer.

6. Complimentary Angels and/or Season's Greetings require approval from Board of Directors.

HONOR BOOK

- 1. Contributions to the Honor Book Fund shall be used for any of the state objectives of CGCI, upon approval of the board of directors. (currently Policy #6)
- 2. The Honor Book shall be on display at convention.
- 3. The Dorothy Copeland Fund was established in May 1988. Contributions shall be sent to the Honor Book chairman who shall forward the money to the CGCI treasurer.
- 4. For each fund (Honor Book and Copeland Fund), this chairman shall make a cash receipt schedule in triplicate keep one copy for the files, send one copy to the CGCI financial secretary, and send one copy and check(s) to the treasurer for deposit into the respective fund.

INSURANCE

- 1. The liability insurance plan is available for an additional charge to qualifying clubs, clubs-at-large, and associate plant societies who pay per capita membership dues.
- 2. The coverage is for investigation, legal defense, personal injury, and property damage due to the negligence of the club, members or guests during any meeting under the control of the club, including flower shows, conventions, tours, sales, etc. There is a limit of \$1,000,000 per accident, with an aggregate of \$2,000,000 for all clubs. A homeowner or commercial policy takes precedence over the garden club's insurance policy.
- 3. Third party certificates for commercial and government agencies are available upon request to the liability insurance chairman. A fee will be charged for each certificate issued.
- 4. A new club or associate plant society may be added to the policy at the time it joins CGCI. A full year's premium will be charged even though first year coverage may be less than one year. Subsequent premiums are due for the following insurance years.
- 5. The insurance year is from February 15th to February 15th.
- 6. The liability insurance chairman will notify clubs of premiums due before November 15.
- 7. Due date of payment is January 15 to avoid late fee.

IRS 501(c)(3) NONPROFIT GROUP EXEMPTION

The application made by CGCI for a group exemption letter recognizing subordinate clubs as organizations of the type described in Section 501(c)(3) of the Internal Revenue Code was approved by the IRS on November 15, 2006. CGCI is thereby authorized by the IRS to grant qualified member clubs full, nonprofit 501(c)(3) tax status. The California Franchise Tax Board has authorized CGCI to grant similar state nonprofit tax status to group exemption subordinates, retroactive to November 15, 2006. Participation in this program is NOT INCLUDED with CGCI membership.

- 1. A club must apply to be included in the program and comply with the guidelines required by the IRS and state of California, and successfully complete the application process (including fee) administered by the CGCI Group Exemption Chairman and CGCI Financial Consultant.
- 2. Upon completing the application and/or renewal process, the Group Exemption Chairman shall make a cash receipt schedule in triplicate keep one copy for the files, send one copy to the CGCI financial secretary, and send one copy and check(s) to the treasurer for deposit into the General Fund revenue category for Group Exemption fees.
- 3. New clubs who successfully complete the application process shall be ratified by the Board of Directors.
- 4. Clubs ratified for the 501(c)(3) group exemption program are required by California law to register with the Franchise Tax Board and the Attorney General's Registry of Charitable Trusts. CGCI notifies the Franchise Tax Board of new subordinates as part of its annual state group exemption renewal, but subordinates must register with the Registry of Charitable Trusts on their own.
- 5. Group Exemption Status is renewable thereafter by February 1 of each year in writing with documentation of activities and financial information and upon payment of renewal fee.

MEETINGS

See FINANCES for "Financial Procedure for sponsoring State Functions and "Grants and Loans".

The president is responsible for the agendas and plans the programs with the host district chairman for board meetings and conventions. (Left this in for reinforcement of Standing Rule 53)

ANNUAL MEETINGS - CONVENTIONS

- 1. At least seven days before the opening day of the convention, the credentials chairman shall check with the membership chairman to verify the number of delegates entitled to represent each club. The number shall be determined by the membership dues received.
- 2. The word "delegate" shall appear on the badges of same at the annual meeting. Alternates, in the absence of delegates, shall wear the delegate badge at all voting sessions. (Currently Policy #7)

NGC AND PACIFIC REGION CONVENTIONS

- 1. CGCI shall be represented at NGC and Pacific Region Conventions as prescribed in the NGC and Pacific Region bylaws.
- 2. The suggested order for the selection of delegates to NGC and Pacific Region conventions shall be as follows: (a) former state presidents in order of seniority of days of service; (b) state officers; (c) district directors; (d) former NGC officers and chairmen; (e) former regional officers and chairmen; (f) state chairmen; and (g) members.

MEMBERSHIP CHAIRMAN

- 1. The membership chairman shall keep current a complete file of all classes of adult membership and shall issue individual membership cards to clubs upon payment of annual and quarterly dues. Associate plant societies shall be sent membership cards if requested.
- 2. All inquiries pertaining to membership shall be referred to the membership chairman.

CLUB MEMBERSHIP

- 1. Club Presidents may attend state board meetings without voice or vote.
- 2. The president of each club, club-at-large, and associate plant society shall receive the state yearbook and subscriptions to GOLDEN GARDENS and THE NATIONAL GARDENER. Partially covered in Standing Rule 91
- 3. The president of each affiliate shall receive a state yearbook and a subscription to GOLDEN GARDENS.
- 4. All classes of membership are encouraged to subscribe 100% to GOLDEN GARDENS for their members.

Procedure for Joining CGCI

- 1. Applications for membership by clubs shall be made to the state membership chairman on an application form prescribed by the board of directors, which should be signed by the district director (with the exception of clubs-at-large and associate plant societies), and accompanied by dues, made payable to CGCI
- 2. Upon receipt of application and dues, the following will be forwarded to the new president: welcome letter, guidelines for treasurer, CGCI Yearbook, Manual & Roster, and sample copies of GOLDEN GARDENS along with subscription information, etc. Clubs receive individual membership cards. Associate plant societies receive individual membership cards upon request. Affiliates receive one membership card for their records.
- 3. New clubs in all membership classes shall be ratified by the board of directors.

YOUTH GARDEN CLUBS

- 1. Applications for junior, intermediate and high school youth groups shall be made to the youth activities chairman and shall be signed by the sponsoring club president and the district director.
- 2. A junior garden club shall be composed of children from pre-school through sixth grade. Intermediate garden clubs shall be students from seventh through ninth grade. High school gardeners shall be students from tenth through twelfth grade and shall include ninth grade in a four-year high school.
- 3. Each club shall be sponsored by a CGCI member club, and shall have all the privileges of CGCI except the rights to vote and hold office. Dues within the youth clubs shall be at the option of each youth club.
- 4. Junior, intermediate, and high school garden clubs shall pay no dues to CGCI.
- 5. CGCI pays dues annually to NGC for youth clubs. Ten dollars covers all youth clubs.

CGCI LIFE MEMBERSHIPS

- 1. Applications are available from the CGCI life membership chairman and CGCI website.
- 2. CGCI life memberships are honorary and require a one-time fee designated in Article IV, Section 3(g).
- 3. Chairman shall make a cash receipt schedule in triplicate keep one copy for the files, send one copy to the CGCI financial secretary, and send one copy and check(s) to the treasurer for deposit into the Scholarship Donations/Life Membership Fund.

- 4. New life members shall be ratified by the board of directors.
- 5. Clubs shall pay state dues for all club members holding state life memberships. State life members shall pay club dues as prescribed by the club's bylaws.

MEMORIALS

- 1. Upon the death of a state board member, a contribution by CGCI from the General Fund in the amount of \$50 shall be made to the current CGCI President's Project. (Currently Policy #8)
- 2. Upon the death of a former state president, a contribution by CGCI from the General Fund in the amount of \$100 shall be made to the current CGCI President's Project. (Currently Policy #9)

NOMINATIONS AND ELECTIONS

Nominations

- 1. Members of the nominating committee are expected to attend nominating committee meetings at fall and winter board meetings, conventions, and at the call of the chairman.
- 2. The nominating committee shall meet prior to the adjournment of the annual meeting at the call of the parliamentarian for the election of its chairman. (Reinforces Article VI Sec 2 (d) 1-2)
- 3. Recommendations of qualified candidates may be sent to the chairman and all members of the nominating committee no later than January 1st in odd-number of years, to serve for information only. The nominating committee is charged with obtaining the best qualified candidates for the offices to be filled and is not bound by recommendations received or suggestions of potential candidates submitted, these recommendations and suggestions serving for information only. Elections
- 1. The election shall be held on the first day that business is conducted at the convention.
- 2. The chairman of the election board shall supervise the arrangements for voting in a polling room separate from the assembly room, provide ballots containing the names of candidates submitted by the nominating committee, with additional spaces for writing in names of nominees from the floor and for the district affiliation of all such candidates, and maintain order and quiet in the polling room. (currently Policy #10)
- 3. An alphabetical list of eligible voting members shall be prepared by the credentials chairman prior to the opening of the polls. The voting hours, which shall not be less than two, shall be determined by the executive committee. No less than three members of the elections board shall be on duty during voting hours. (Currently Policy #11)
- 4. The ballot box shall be sealed after the opening of the polls and until the count begins. The count shall continue without interruption until completed, when the ballot box shall again be sealed unless a recount is called for by the executive committee. At no time shall the ballots be handled by anyone other than the election board. Sealed ballot box shall be given to the recording secretary for storage until expiration of the term. At that time, the ballots shall be destroyed. (Currently Policy #12)
- 5. The chairman of the election committee shall report the results of the election to the president at the next business session conducted at the convention. (Currently Policy #13)

OFFICERS AND BOARD MEMBERS

- 1. Officers, district directors, chairmen of standing and special committees shall present written progress reports at the fall and winter board meetings and the annual meeting unless otherwise specified.
- 2. Oral reports shall be limited to three minutes unless otherwise specified. There shall be three copies: two full-length reports, one for the president, one for the editor of GOLDEN GARDENS; and one condensed copy of not more than 100 words for the recording secretary.
- 3. Three "master" procedure books are created electronically for officers, chairmen and district directors. One copy of those masters is put on a CD for "permanent" retention and one copy is available on CGCI's website. Anyone, including the officer, chairman, district director or coordinators and president can access. At the beginning of each term, the chairman's procedure "book" would be updated to add/delete positions and all three would be updated for content as needed and for those who need only the information that applies to their position. Each position would have a separate page/division within the master procedure book so that only that one item needs to be downloaded/printed or saved. A paper book could be printed out for those few individuals who do not have Internet access.
- 4. A chairman should be consulted and be present, if possible, when any change in his/her area of responsibility is being considered.

SCHOLARSHIPS

1. In addition to the CGCI Scholarship Endowment Fund, a state fund has been established to provide scholarships for college juniors, seniors and graduate students who plan careers in fields related to the activities and objectives of CGCI.

- 2. Contributions (other than Life Memberships) to the Scholarship Donations/Life Membership Fund shall be payable to CGCI and sent to the scholarship chairman. This chairman shall make a cash receipt schedule in triplicate. The chairman shall keep one copy for the files, send one copy to the financial secretary, and send one copy and check(s) to the treasurer for deposit in the Scholarship Donations/Life Memberships Fund.
- 3. Life Membership applications along with the one-time fee shall be sent to the life membership chairman who shall make a cash receipt schedule in triplicate. The chairman shall keep one copy for the files, send one copy to the financial secretary, and send one copy and check(s) to the treasurer for deposit in the Scholarship Donations/Life Membership Fund.
- 4. With the approval of the CGCI executive committee and the board of directors, additional scholarships may be offered through CGCI by individuals, clubs, or districts, with students making application through the CGCI scholarship chairman. (Currently Policy #14)

STATE PROJECTS

- 1. Member clubs are encouraged to give financial support to CGCI and NGC projects.
- 2. The advisory council shall monitor current state projects to determine their viability and worthiness and shall advise the executive committee at each winter board meeting on the continuation or termination of each state project.

MISCELLANEOUS PROCEDURES

National Garden Clubs. Inc. Personnel File

In accordance with NGC requirements, the board of directors shall certify and/or recertify the names and eligibility of CGCI members requesting to be listed in the NGC personnel file.

Product Endorsement or Commercial Enterprises

Proposals to endorse any products or commercial enterprises shall be thoroughly investigated to determine that such endorsement would not be in conflict with CGCl's stated objectives, or jeopardize CGCl's tax exempt status at any governmental level.

Amenities for NGC President, Pacific Region Director when Guests of CGCI When the Pacific Region Director or NGC president is the guest of CGCI, it is a courtesy to provide lodging and meals one day prior to and following a board meeting or convention as well as lodging, meals and registration during the meeting. (Currently Policy #16)

Approved at 2011 Winter Board:

Every ten (10) years, having begun at the annual meeting in 1970, a redwood tree shall be purchased that is selected by The Sempervirens Fund at Big Basin Redwoods State Park to honor those CGCI Presidents in office during that decade. Money to come from the Honor Book Fund. CGCI Board Designated Honor Book Fund shall pay meal expenses for CGCI guests and speakers invited by the Executive Committee.

- The mission blue butterfly was placed on the Federally Endangered Species list in 1976 and is only located in the San Francisco Bay Area, and
- The mission blue butterfly has declined to less than 25,000 in population, and
- The silver lupine (*Lupinus albifrons*) that serves as one of the three mission blue butterfly's host larval plants, is susceptible to the fungal pathogen *anthracnose* during heavy winter rainfall, and
- The objectives of California Garden Clubs, Inc. (CGCI) are as stated in the Articles of Incorporation and also as stated in Article II Section 5 of the corporation's Bylaws, and,

Whereas, these Bylaws

- Assist in projects for the conservation of our natural resources
- · Promote, create and further an interest in amateur gardening, in plant life, and in bird life, and
- Cooperate with other agencies in furthering interests in educational areas including environmental awareness, and

Whereas,

 The mission blue butterfly is in need of financial support for its species to survive, and therefore, be it

Resolved, That California Garden Clubs, Inc. partner with the Golden Gate National Park Conservancy (GGNPC) to adopt this fund raising project to:

- Increase lupine diversity by propagating and planting pathogen-resistant summer lupine (*Lupinus formusus*) and varied-color lupine (*Lupinus variicolor*) throughout Golden Gate National Park and Recreation Area
- Support the federally endangered mission blue butterfly
- Stabilize populations during years with fungal outbreak
- Allow these populations to increase over the long term and;

Resolved.

- That funding for this five-year fund raising project strive for a goal of \$3,000 in annual donations
 to be used for propagation materials, planting and scientific experiments for hard-to-grow lupines
 and;
- That a new Temporarily Restricted Fund be established within CGCI designated to receive

- Three <u>Flower Show Symposiums</u> were held; two in Bakersfield in and one in conjunction with the California State Flower & Garden Show.
 - A state standard flower show (only the 7th in California's eighty year history) was held in April, 2011 at the California State Flower & Garden Show at Cal Expo in Sacramento, CA. More than 10,000 attended. The schedule was designed so it coincided with our Flower Show symposium.

CGCI was an official sponsor of the California State Flower & Garden Show and the San Francisco Flower & Garden Show
This term we invited club presidents from all over the state to come to Board meetings in every area we visited.
Hundreds of club members attended CGCI Board meetings and our leadership Forums put on at those meetings, as we did at this convention,
for free.

The CGCI Board voted to give the District Directors as a group, the chance to grant some fund to districts that needed some extra support for whatever reason they saw fit.

Buttes District rose from the ashes and held a successful Wildflower Weekend in Oroville last month.

- A CGCI Member Award of Distinction was created for clubs wishing to honor members who have given distinctive service to their club with a certificate and pin for \$50. Proceeds benefit the Special Education Fund.
- A pin was designed for new CGCI life members. A \$100 donation to CGCI's scholarship fund now includes a certificate and a pin for the recipient.
- A Planned Giving program was established with two endowment funds: Scholarship and the California Garden Club Endowment Fund.
- o the Planned Giving program itself needs to continue to be molded and defined so it can meet the needs potential donors Speaking of working together....
- During this term, \$82,824 was collected for 1218 plantations to support the Penny Pines reforestation program.
- The Presidents Project for 2009-11 was Kids Growing Strong;

More than \$25,000 was raised for this project that reached more than a half million kids and their families during this term. CCGI Committee Chairmen Reports

Arbor Day, Lorraine Ornelas: It has been a pleasure to serve as Arbor Day Chairman for the past four years. Members in many clubs have participated in worthwhile celebrations and I have received reports from Naples Island GC and San Pedro GC in Costa Verde District, Santa Rosa GC of Luther Burbank District and Pinole GC of Bay Bridges District. Easy Grant applications were received from 6 clubs and checks for \$125.00 were issued to Anderson Valley GC, Long Beach GC, Pinole GC, Ramona GC, Tuolumne County GC and Willits GC. A reminder that pictures and a story about your Arbor Day Celebration should be forwarded to the *Golden Gardens* editor as part of the requirement for this grant. As an aside I received a picture of a tree being planted and all you could see of the young ladies who helped with the planting was their legs. It is a federal law that if a minor's picture is to be taken you must have a written release from the parent or guardian to do so.

Associate Plant Societies, Dorothy Dempsey: We lost one society this year: Mediterranean Garden Society SC Branch, with a loss of 125 members. We gained one new club – Sonoma County Orchid Society, with 95 members. We now have 3,775 paid members in 53 Associate Plant Societies. This past week this chairman has phoned and emailed all 53 societies checking current presidents and treasurers. A number of new presidents and treasurers were found. This chairman now feels the list is current and ready for the new APS Chairman.

Awards Finance, Win Archibald: CGCl 2011-2013 Awards Sponsor Commitment letters were prepared for awards to be given in 2012 and 2013. A team effort, the letters were updated by the Awards Finance Chairman and mailed by the 2011-13 Awards Chair. President-Elect, Julie West, was chief advisor for the project. By 2011 Convention the majority of sponsors had renewed their commitments for the next term and replacements found for most non-renewed awards. Spontaneous payments of \$1160.00 were received from 13 sponsors.

Backyard Habitat, Margaret Strachan: This chairman provided an exhibit for the 2011 convention covering the five basic requirements for a backyard habitat. Pamphlets were provided from The National Wildlife Federation and the North American Butterfly Association. The National Wildlife Federation pamphlets provided information as to how to obtain certification and plaques which identify gardens as a certified backyard habitat. All of the pamphlets were picked up by attendees at the convention. This chairman has mailed a package to her successor, which contains details of the work done during the 2009/2011 term, including titles of *Golden Garden* articles submitted.

Business Commendation Chairman & Discount Coordinator, LaVerne Harms: Certificate of Commendation issued since February, 2011: San Jose GC – Almaden Valley Nursery, 15800 Almaden Expway, San Jose. New Participating Sponsors: Valley Hills Nursery, PO Box 534, Carmel, CA 93923 (applied through CGCI website) and Western Garden Nursery, 2756 Vineyard Avenue, Pleasanton, CA 94566 (sponsored by Livermore-Amador Valley GC).

California Native & Invasive Plants, Donna Thomas: Stanleya pinnata – Prince's Plume or Desert Plume: Prince's Plume is a striking, rather dramatic plant. It is a perennial growing two to five feet tall from a somewhat woody base. Each stem terminates in a showy, densely flowered plume up to one and half feet long. Its name "pinnata" means plume. Though small, the flowers are so numerous that the effect is quite spectacular. The petals with the long slender stamens sticking out (4 tall and 2 short) give the flower an airy look and give the dense flower spikes a bottle-brush appearance. It is in the mustard family, is drought tolerant, cold hardy and can be grown from seed. You can order seed from www.plantsofthesouthwest.com.

California State Parks, Barbara Dodge: On May 13, 2011 the Department of Parks and Recreation released a list of 70 parks that will be permanently closed to the public, the direct result of the \$22 million cut enacted by the Governor and the Legislature earlier this year. Closures lists have been released in the past in response to previous budget cut proposals, but this is the first time in the 100 year history of California's state park system that state park closures will be implemented. Permanent park closures will begin in September. Among the many state parks that will be off-limits to the public will be Del Norte Coast Redwoods State Park, Henry W. Coe State Park, Pio Pico State Historic Park are but a few. The full list is long and includes 40% of all state historic parks. This unprecedented plan will close the doors of 25% of California's state park system and will impact all regions of our state, Park closures will have very real impacts on the people of California, the resources our parks protect and the economy. The California State Parks Foundation urges that you send a letter to your legislators and the governor, voicing your opposition to these closures and showing your continued support for California's state parks. Action is urgently needed as policymakers will be making additional decisions in the next weeks about the state park budget that may have further impacts to our state parks (from California State Parks Foundation newsletter).

Climate Change, Dwight Holford: The state of scientific knowledge regarding climate change as reported by the US EPA (relying heavily on direct quotes): What's Known With Virtual Certainty – Human activities are changing the composition of earth's atmosphere; the atmospheric buildup of CO2 and other greenhouse gases is largely the result of human activity; an "unequivocal" warming trend of about 1.0 to 1.7 degrees F occurred from 1906-2005; the major greenhouse gases emitted by human activities remain in the atmosphere for periods ranging from decades to centuries. It is therefore virtually certain that atmospheric concentrations of greenhouse gases will continue to rise over the next few decades; increasing greenhouse gas concentrations tend to warm the planet. What's Very Likely: a growing number of scientific analyses indicate, but cannot prove, that rising levels of greenhouse gases in the atmosphere are contributing to climate change (as theory predicts). In the coming decades, scientists anticipate that as atmospheric concentrations of greenhouse gases continue to rise, average global temperatures and sea

levels will continue to rise and precipitation patterns will change. What's Not Certain?: Important scientific questions remain about how much warming will occur, how fast it will occur, and how the warming will affect the rest of the climate system including precipitation patterns and storms. Answering these questions will require advance scientific knowledge in a number of areas: Improving understanding of natural climatic variations, changes in sun's energy, land-use changes, the warming or cooling effects of pollutant aerosols, and the impacts of changing humidity and cloud cover; Determining the relative contribution to climate change of human activities and natural causes; Projecting future greenhouse emissions and how the climate system will respond within a narrow range; Improving understanding of the potential for *rapid or abrupt climate change*.

Educational Schools Finances, Mary-Jo Noth: Since the 2010 CGCI convention, Environmental Studies School course 3 and Gardening Study School Series 21 course 3 have been held, and both were self-supporting. Flower Show School [Sacramento] course 1 received a CGCI grant of \$500 from the Helen Minor restricted fund, and made sufficient profit that further CGCI support was not necessary for course 2. Landscape Design School Series 24 received a CGCI grant of \$500 from the Eleanor Miller restricted fund, and was also sufficiently profitable so that additional CGCI grant support was not necessary for course 2 and 3. Please remember that a grant for a NGC school is income, and thus may reduce the fees needed to be charged to school attendees.

Endowment, Robert Gordon: The gain in our scholarship endowment fund since investing last fall has been 1.86%. We invested 60,325.65 and our current balance is 61,448.83. The CGCI Endowment will be funded during the summer of 2011. Donations are accepted anytime to these endowments. Please make check payable to CGCI, mark in the memo which endowment and give the check to the endowment chair. The Committee will be reporting at fall board the levels of giving and the perks that go with each level. There will be a "thank you" event at Convention 2012 for those with accumulative donations of \$500 or more. A check for \$1,000 was received from Principal Financial Group as a donation to the Scholarship Endowment.

Flower Show Awards, Gudrun Kimmel: This chairman processed 12 registrations and selected evaluating judges for the shows. All of the completed ones have been advised that they are eligible for awards. This chairman would like to thank her Judges Council for forming panels to judge last year's Books of Evidence for this year's award presentation. Please register your Standard Flower Shows with the new Flower Show Awards Chairman, Susan Coolidge. Flower Shows must be a Standard Show and must be registered for new judges to receive judging credits toward their credentials.

Flower Show Schools, Dolores Moffat: 9 new Judges: Rob Crenshaw, Coronado; Adele Kelly, San Diego; Linda Lang, Banning; Sharon Lowry, Coronado; Dyanna Madro, Escondido; Emily Troxell, Poway; Barbara Weiler, Vista; Marilyn Gross, Alamo; Carolyn Neumann, Fairfield. Flower Show School Course III will be October 18-20, 2011 in Sacramento at the Shepard Garden and Arts Center. Plans for a Symposium in January or February are in the works, more information later.

Gardening Study Schools (GSS), Greg Pokorski: Consultant status has been reviewed and refresher reminders sent to Consultants in preparation for the Tri-Refresher held at this convention. Course IV – the final course of Series 21 in Loomis – sponsored by Golden Foothills District – was rescheduled from April to September 27 & 28. Sue Bennett is the Local Chairman. This Chairman took the Tri-Refresher at this convention for credit. Kudos to the local committee who organized this, their first venture in this area. The subject matter was informative, the instructors knowledgeable, and the scheduling and adherence to requirements for educational content was stellar and commendable. A Birefresher in GS and LD will be sponsored by Dos Valles GC in Valley Center on October 28 & 29 to accommodate 8 lapsing Gardening Consultants, but open to all. This chairman's priority is to get a new school series, # 22, under "construction." 3 items of information about GSS have been placed in the District Director folders. Please see the GSS exhibit here. Club presidents & District Directors, Consultants for all educational programs are listed in the CGCI Yearbook. These lists are updated annually. Know and recognize the Consultants in your area. Enlist them to contribute to your programs and events. This chairman will be continuing as CGCI and NGC GSS Chair and also serving as NGC Schools Coordinator. Consultants and students are invited to write articles and submit ideas for articles for *The National Gardener* and other qarden club publications.

Honor Book, Geri May Thirloway: Since the CGCI Fall Board Meeting in September, this Chairman has received \$323 in Honor Book donations from 4 individuals, Southwestern Judges Council, Luther Burbank District, Santa Rosa Garden Club. From June 2010 to May 2011, this Chairman has received a total of \$1,118 in Honor Book donations. Correction to Cathy Biggins' Fall Report: \$770 should be \$795 in Honor Book donations. From June 2009 to May 2011, this Chairman has received \$1,668 in Total. Honor donations: 1 donation for 1 person in 2009; 13 donations for 13 people in 2010; 1 donation for 1 person in 2011; Memorial donations for wonderful members who died: 1 donation for 1 person in 2009; 22 donations for 11 people in 2010; 5 donations for 3 people in 2011.

Horticulture, Jim Bathgate: With good winter rains, many native wildflowers are showing their spring colors. Poppies, lupine, godetia, ceanothus, salvia and penstemon have bloomed or soon will. A few mariposa lilies have shown up on the hillside near our home in San Diego County. Matilija poppies are flourishing, chamise and deer weed are in heavy bloom. A few less known wildflowers like Rush Rose and Keckiella are joining the crowd. This is a good season to observe and enjoy our native landscape. Many fruit trees have already set fruit and some early ones are already mature. The winter rain promoted peach leaf curl and some other diseases but the water was very welcome. Various pests are a continuing problem for fruit growers. Light Brown Apple Moth, Asian Citrus Psyllid, the European Grapevine Moth, and the Spotted Wing Drosophylla add to the usual concern about aphids, scale and mites. The water supply situation is better this year but with continued high prices, considerable fruit acreage is abandoned or put into other crops. With this report the Horticulture chairman ends his period

on the CGCI Board. It has been very enjoyable to be part of this dynamic organization. I send my thanks and good wishes to the many great gardeners I have met and worked with.

Landscape Design Study Program, Alexis Slafer: Costa Verde District is sponsoring the current Landscape Design Study Program – Series 24 – at the South Coast Botanic Garden, Palos Verdes Peninsula. Course 4 is scheduled for September 22nd & 23rd. Landscape Design School, Series 25, sponsored by Colfax Garden Club, begins September 10th, with the next 3 courses being held weekly beginning October 8th. Both schools will be completed within the year. Landscape Design School handouts are available in the mailbox, display in the exhibit hall & on the CGCI website.

Legislation/Government, Chuck Goodwin: This Chairman has been reporting to you on the financial crisis in the California State Parks since the 2009 Fall Board, in Concord. At that time it was expected that as many as 100 of the more than 270 park units faced closure. It was estimated that as much as \$20.2 million general fund dollars would be cut from the State Parks budget. The CGCI Board of Directors adopted a position paper, at 2010 Winter Board, to "Support the Preservation and Maintenance of California State Parks." CGCI urged the development of long-term fiscal and the best management practices available to insure that every California State Park will exist for future generations. The position paper was promoted in Golden Gardens and the e-Newsletter. The 2010 Convention report announced that the final impact for the year was that, while no parks were permanently closed, most units had reduced services, mostly through reduced days of operation or seasonal closures. The General Election of November, 2010 contained, among other measures, Proposition 21, which would place an \$18 surcharge on the vehicle license fee, raising more than \$500 million annually. Sponsored by the California Parks Foundation, the measure was soundly defeated by the voters. Then last Friday, May 13, Governor Brown announced that 70 state parks across California will be closed, possibly beginning July, 2012, eliminating as many as 220 jobs. The \$22 million budget cut will help to shrink the state's \$26 billion deficit. About \$75 million has been cut out of the parks budget over the past decade. Park staffing is currently at 1979 levels but the system has 500,000 more acres and 10 million more visitors. The closure list was evaluated based on their historic significance, number of visitors, revenue generated and the ability to physically close them. It is estimated that the parks will retain 92 per cent of the 65 million annual visitors and 94 per cent of existing revenue. There is ongoing discussions between legislators and the governor over possible tax measures to be placed on future ballots and legislation passed aimed at helping cities and counties (and nonprofits) enter long-term agreements to manage the closed parks.

Member Award of Distinction Program, Mary-Jo Noth: Since May 2010, seven clubs and one district have chosen to honor members of distinction. Information publicizing this program has appeared most recently in the Winter 2011 "Golden Gardens" and in an exhibit at this convention that shows a sample award certificate and pin and a list of individuals who have received the honor to date. An additional club member will be honored in June. The application is available on the CGCI website and should be submitted to the chairman with the award fee of \$50.00, payable by check to CGCI. Proceeds benefit the CGCI Educational Publications Fund.

National Garden Week, Victoria Lucido: So many of you know the first week in June is National Garden Week. Proclamations, visits to schools, parks, nursery homes and helping make our communities more productive and beautiful. This chairman has not been as busy as she had hoped to be. We did give one \$50.00 grant to one garden club. Material was sent to Canyon Crest GC. So many clubs are busy with so many projects. Thanks to all for your efforts in making California beautiful. Giving educational material or lectures to our communities on gardens, landscaping with natives, planting drought resistant plants, organic gardening, water conservation and backyard vegetable gardens are very good projects. Making designs not only for homes but for the community to see at flower shows and for libraries or rest homes to see our talents. Please keep up the good work and don't forget to tell your local media what you are planning.

Propagation "Free Plants", Lee Bathgate: Maybe you don't have a greenhouse for propagation. You can easily propagate the perennials and shrubs (even some trees) in your garden by some form of layering, and for certain plants, layering is the best method. Layering is causing roots to grow from a branch while it is still attached to the parent plant. There is less shock as the "cutting" is still being fed. Methods of layering include simple ground layering, pot layering, tip layering, compound layering, mound layering, air layering and natural layering. Simple ground layering: Bend a low growing branch about 6 to 12 inches from the tip. Remove any leaves from the bent area and scrape the bark or cut a slanting tongue on the underside. Dust with rooting hormone and bury in a sloping trench, bending the tip up. Peg down with a "U" shaped wire and cover with loose moist soil. A rock can also be used to hold it down. Stake the green tip and keep moist. The rooting time will vary from a few months to a year depending on the plant. Dig carefully to check for roots. When well-rooted, sever and pot up or plant directly. Keep well-watered. This works for shrubs, climbers and azaleas. Your friends will be happy with the 'gifts' of your extra plants and you can have fun seeing the results.

Tours (2011-13), Robert Gordon: The CGCI Tour for the first year of this term will be in April 2012 departing Amsterdam on the 12th. It is an 8 day river cruise in Holland that will include tulip time in Keukenhoff and the Floriade. The Floriade is a horticulture show held in Holland every 10 years. The cruise is aboard the AMA Verde. A ship owned by an American River Boat Company. All meals included, complimentary wine soft drinks and beer at each dinner. Cost starts at \$2,279 for the Piano Deck. Deposit \$400 per person. Final payment 90 days prior to departure. Questions call Bob Gordon 805-541-1532 or Chris Merkel 877-651-7447. Reservations call Chris Merkel 877-651-7447 Our goal is 40 rooms. We have booked 15 to date. Book quickly as the ship will sell out early.

Webmaster, Lynne Hansen: In a one week period the CGCI home page has had over 7500 hits. RSS Feeds (Really Simple Syndication) are also very popular. Robert Schuler's "Garden Patch Pointers" is a big hit. People want to be notified when he posts his next blog. 22 Clubs sites have been put up on the CGCI server and also 6 District Sites have been put up too. This is the tenth year that I have been working on the

CGCI website and Ed Dempsey wanted his old job back as webmaster and he deserves the job, so I will be doing other jobs for CGCI in the future. It has been a pleasure serving you.

District Director Reports

Bay Ocean, Nancy McDougal: Each club's activities are unique; but, whether centered on horticulture, floral design or public beautification, members enjoy working together. Meetings focused on outside speakers as well as hands-on activities. Outreach included two annual garden tours, speaker programs, floral displays, community gifts and scholarships. Our newest club coordinates local community vegetable gardens. Many older clubs are experiencing decreasing memberships; but, choose to continue usual programming. They do serve the needs of their members; but, those clubs choosing alternate meetings & activities are becoming more important in our community. District is a forum for information exchange and help for all the clubs.

Buttes, Donna Beronda: 2011 has been a great year for Buttes District. Thanks in large part to CGCI for financial support, and to both Maryanne Lucas and Julie West for their personal support Northern California Wildflower Weekend netted \$1000 for the Concow School garden and almost \$1300 for Buttes District. Most importantly, almost all Buttes District clubs actively participated in the event. Individual clubs are also flourishing . . . Garden Club of the Lake Oroville Area has doubled club membership and Chico Horticulture hosted the garden pavilion including floral design, horticultural judging, a plant sale and a Buttes District table at the Soroptomist Home & Garden Show in March. Members of our district clubs were also recognized for their community contributions. The Garden Club of Colusa County received an award from the Colusa County Library for their beautification efforts in three separate towns and Jayne Locas was named Paradise Woman of the Year by the Elks Lodge for her work with Paradise Garden Club and the "Daffodils Across the Ridge" project.

Cascade, Anne Capes: Cascade District has nine clubs: each one unique and focus on a different emphasis. In spite of different personalities, the tie that binds them together as a vibrant district is community outreach. For example, one of the clubs recently teamed with Meal on Wheels to provide flower arrangements for the meal trays. Every month the members make 40 to 60 arrangements for that purpose. One of the members is a commercial flower grower and provides all the flowers. Three of the clubs are in towns that have highways going through the middle of town. The clubs in these towns have landscaped the median – each one with a different "flavor." One town has a history as an early California settlement and is still a cowboy town. The landscaping features iron near-lifesize figures of cowboys and horses fabricated by a local artist. The garden club maintains the surrounding plants. Attendance at District meetings is members from every club and is not less than seventy members from a total membership of 356 = 20%.

Channel Islands, Carol Amenta: Pleasant Valley GC had another busy year. First a speaker on how and why a Chinese garden is organized, then a florist gave them tips on decorating holiday wreaths for their annual wreath making fundraiser. They had a presentation on dahlias and on irises. A member also gave a demonstration on how to make hypertufa pots and large leaves. They continued their monthly programs at the Camarillo Health Services Center with Alzheimer's patients. The clubs donated funds to the local grammar schools for their gardening projects and to the Camarillo Community Gardens. Members still maintain garden around the church fountain where they hold meetings. The Conejo Valley GC had speakers from local nurseries on topics of Bare Root planting & Native Plants. A representative from Shadow Oaks Wildlife Care spoke on animals in our gardens and President Darcey Lober from the Conejo Valley Organic Garden Club speaking on herbs. The club also had progressive luncheon to three of their member's homes. They visited some beautiful gardens, had delicious lunch and wonderful company. Another successful activity that was continued from last year is the Sack Lunch in the Garden after the general meetings. Members bring their lunch and then spend time in a member's garden after the meeting. It is great way to get to meet new members and get updated on "old" friends. The Westlake Village GC's 38th Annual Garden and Patio Tour was again, a great success providing three \$1,500 scholarships to students transferring from Ventura, Oxnard and Moorpark Community Colleges to four-year universities or colleges. The Channel Islands District luncheon was chaired by the 2010 Convention co-chair Jean Reiley. "Sustainable Landscaping Featuring the Arboretum All-Stars" was the topic selected by noted speaker Diane Beeler. Beeler is a Certified Master Gardener and member of the Association of Professional Landscape Designers with over 25 years of horticulture experience. She is a published writer and Board Member of the Ventura Botanical Gardens. The items donated by the community and Channel Island District clubs provided for a very successful fundraising auction.

Costa Verde, Ruth Brooker: During the term of this director she wanted to have the members take an active part in going GREEN and we had good response here. We wanted to have the district board, especially the presidents, express their opinion and ask questions. The board meetings were in the form of a round table. Attending members wanted to know solutions to club problems and wanted to know what the district and CGCI had to offer them. Members were enthusiastic. We think most of them gained a better understanding about our garden club family. Lorraine Ornelas will be the new director.

Desert Empire, Joanne Latimer: On the weekend of April 15, 16 and 17 all three of our clubs participated in the First Annual Wildflower Festival of Indian Wells Valley. The clubs were out in force to attract attention of people attending the week end event. We sold plants, hats seeds, gloves, garden tour tickets, and cookies. The PR that we all received was very encouraging. And, we all had fun. We were happy as a District to make a \$100 donation to "Kids Growing Strong". Our district is pleased to have a strong kids program going on in our district. Stephie Baker has been tireless in working with the kids. Our clubs are busy planning the installation of the new officers. One has just completed the

installation and the other two are upcoming. It is always exciting to see a few new faces sitting on the board. Each of the clubs have at least one "shining new face" on their board. As outgoing DFD director I see we have had a great 2 year together; starting with the 2009 California Garden Club Inc. fall board meeting. Maryanne Lucas' CGCI presidential visit in May of 2010 hosting a tour to a local Children's Summer Camp, Wine Tasting, and evening dinner, Maryanne being our special guest and speaker. DFD continued to meet CGCI and DFD objectives by having three great tours, a cookbook fundraiser, and several DFD General Membership Meetings having great host clubs and great speakers. These activities allow DFD to create, promote and further an interest in amateur gardening, plant and bird life.

Golden Foothills, Sue Bennett: I would like to talk about the Good, Bad and Ugly. The Ugly: On March 19 we co-hosted a Kids Gardening Day with a local Nursery to promote Kids Growing Strong – it was cold, windy and rainy. The Bad: One President resigned, one president was in tears, and two clubs wanted to fold. The Good: Members have participated in 8 venues for the Kids Growing Strong Program, the clubs continue monthly meetings, tours; May & June are the months for plant sales and installations. To end, I want to repeat something Chuck Goodwin told me, don't focus on the members who don't attend meetings, but put your energy on the ones who do.

Humboldt, Janean Guest (Incoming Director): From February to May, Humboldt County Garden Clubs have ignored many FEET of rainfall! While holed up around warm fires, dreams of Spring activities took shape. Southern Humboldt Garden Club has enthusiastically prepared for their Sunday, May 15th, 60th Annual Small-Standard Flower Show & Plant Sale, with the theme of "Through the Years." Admission is Free. Fortuna Garden Club held its Annual Daffodil Show in March, to the delight of the hundreds in attendance. This annual club project is greeted with much anticipation and appreciation by all 'north-coasters.' Fortuna Garden Club also hosted a visit of CGCI President Maryanne Lucas, much to the joy of Humboldt District Garden Club members. Ferndale Garden Club has been busy planning special events for the 2012 CGCI State Board Meeting. Their enthusiasm is indicative of North Coast hospitality and good nature. Eureka Garden Club continues to address community beautification projects, some are focused on the waterfront. Patrick's Point Garden Club held the 5th Annual North Coast Garden Event on Mother's Day, where implementation of the much appreciated CGCI's "EASY GRANT" FOR \$250 took place. There were three lectures and the presentation of two separate awards for educational projects in the community. Admission was Free! Installation took place in Trinidad, at our district meeting on Tuesday, May 3, with Past CGCI President Mary Lou Goodwin conducting the ceremony. A lovely day!

Luther Burbank, Bev Davies: Club members devoted most of their time toward the 2011 Convention. California Garden Clubs, Inc. RULES OF ORDER FOR BOARD MEETINGS, 2011-2013

- 1. Regular meetings of the board of directors shall be Organizational, Fall, Winter and Pre-Convention meetings.
- 2. Permission for non attendance at any regular meeting shall be obtained from the president.
- 3. Permission for a guest to attend any meeting of the board of directors shall be obtained from the president. Guests shall have a special identification.
- 4. Board members are requested to be prompt in their attendance.
- 5. Oral reports shall be limited to two (2) minutes each unless otherwise announced.
- 6. All but the simplest of motions from the floor shall be in writing and sent to the president or presiding officer, with copies to the recording secretary and parliamentarian, before debate may proceed.
- 7. Whenever practical, motions to be considered for presentation at any board meeting shall be submitted, in writing, to the president with copies to each member of the Executive Committee, to be received at least 10 days prior to such meeting.
- 8. No issue shall be debated without first being placed on the floor by a motion which has been seconded.
- 9. Any member of the board of directors wishing to obtain the floor shall rise and when recognized by the president or presiding officer, shall state his/her name and official capacity.
- 10. If there is an issue involved with any motion on the floor, a duly recognized member may speak no more than twice on the same issue, except for the proponent of the motion, who may speak a third time to close the debate. Speakers shall be allowed two minutes each. *NOTE: No member may speak a second time until all members who want to speak have spoken a first time.*
- 11. The bylaws and standing rules of CGCI, together with *Robert's Rules of Order Newly Revised*, shall govern all proceedings of all meetings of the board of directors.
- 12. These Rules of Order may be suspended at any meeting of the board of directors by a two-thirds (2/3) vote of the board members present and voting, providing that the proposal to be presented is not in conflict with CGCl's bylaws or the fundamental principles of parliamentary law.
- All cell phones and pagers are to be turned off or set to vibrate prior to entering the meeting room.

2011-2016 Project Mission Blue Resolution

Whereas, Over one hundred square miles of parkland ranging from the San Mateo County coastline north to Point Reyes National Seashore constitutes Golden Gate National Park and Recreation Area, and

- The mission blue butterfly was placed on the Federally Endangered Species list in 1976 and is only located in the San Francisco Bay Area, and
- The mission blue butterfly has declined to less than 25,000 in population, and
- The silver lupine (*Lupinus albifrons*) that serves as one of the three mission blue butterfly's host larval plants, is susceptible to the fungal pathogen *anthracnose* during heavy winter rainfall, and
- The objectives of California Garden Clubs, Inc. (CGCI) are as stated in the Articles of Incorporation and also as stated in Article II Section 5 of the corporation's Bylaws, and,

Whereas, these Bylaws

- Assist in projects for the conservation of our natural resources
- Promote, create and further an interest in amateur gardening, in plant life, and in bird life, and
- Cooperate with other agencies in furthering interests in educational areas including environmental awareness, and

Whereas,

The mission blue butterfly is in need of financial support for its species to survive, and therefore, be it

Resolved, That California Garden Clubs, Inc. partner with the Golden Gate National Park Conservancy (GGNPC) to adopt this fund raising project to:

- Increase lupine diversity by propagating and planting pathogen-resistant summer lupine (*Lupinus formusus*) and varied-color lupine (*Lupinus variicolor*) throughout Golden Gate National Park and Recreation Area
- Support the federally endangered mission blue butterfly
- Stabilize populations during years with fungal outbreak
- Allow these populations to increase over the long term and;

Resolved,

- That funding for this five-year fund raising project strive for a goal of \$3,000 in annual donations to be used for propagation materials, planting and scientific experiments for hard-to-grow lupines and;
- That a new Temporarily Restricted Fund be established within CGCI designated to receive donations and forward all donations received to the GGNPC Park Stewardship program twice a year on January 15 and June 15 and;
- That checks made payable to CGCI be sent to the CGCI State Chairman for the project, who will keep records of
 the transactions for CGCI and forward the donations to the CGCI treasurer for deposit into the new Temporarily
 Restricted Fund established for the 2011-2016 Project Mission Blue and;
- That the project is reviewed in 2016 when it is mutually re-evaluated by CGCI and GGNPC to renew the partnership and fund raising project.
