WHEREAS, California Garden Clubs, Inc. has been asked to participate in this refurbishment project,

THEREFORE, BE IT RESOLVED, that California Garden Clubs, Inc. ## Golden Gardens Proposed Bylaw Amendments

PROVISO: All bylaw amendments relating to the *Golden Gardens* including Article XIII Sec. 1; Article XIII Sec. 4 and Article XIII Sec. 7 shall take effect at the close of the CGCI Convention June 6, 2013. NOTE: If the amendment to Article XIII Sec. 1 (Item #10) were to fail, the remaining proposed bylaws amendments as respects *Golden Gardens* will not be presented for consideration.

## (9) ARTICLE XIII - GOLDEN GARDENS (page 136)

#### Now reads:

Sec.1. The official publication of CGCI shall be Golden Gardens, electronic or print.

## Parliamentarian, Greg Pokorski

2012 CGCI Convention, Sacramento Parliamentarian's Report Greg Pokorski June 5, 2012

This officer worked with the Recording Secretary in minutes drafting and review following our Winter Board Meeting, worked with our President on agendas for meetings at this convention, and with our President, updated our Rules for Conventions and Rules of Order for Board Meetings.

It was rewarding and educational to conduct a workshop in April geared toward reviewing all aspects of parliamentary procedure for the purpose of preparing participants to take the National Association of Parliamentarians' membership exam.

This officer attended the parliamentary workshop presented by NGC Parliamentarian Joan Corbisiero at the recent NGC convention in Buffalo. Copies of her handout on the 11<sup>th</sup> edition of Robert's Rules of Order are available at the parliamentary exhibit in the exhibit room and have been placed in the District Director and Officer mailboxes. All are reminded to buy and use the 11<sup>th</sup> edition, published last fall.

Madame President, thank you for the opportunity to serve you and CGCI during this administration.

## Third Vice President, Pat Clayes Awards Committee Chairman

For the 2011 awards year, approximately 250 award applications were submitted by clubs.

At the NGC Convention in Buffalo last month, CGCI and its clubs and districts received 16 awards. Pacific Region has not held its convention yet, so CGCI does not know the outcome of the Pacific Region Awards yet.

For the 2012 CGCI awards year, in keeping along the lines of NGC and Pacific Region, most CGCI award entries will no longer require books of evidence. Only Publicity Press Books, certain Flower Show Awards and Photography Awards will still require books of evidence. Instead of the books of evidence, an application form must be completed which will be limited to three printed pages – front sides of pages only. All required information, photos, lists, etc. will have to be inserted onto these three pages. Knowledge of cropping and reducing on the computer will help, as will the use of smaller fonts. This chairman will be amending the 2011 Evaluation Sheets for the applicant to be able to fit all required information onto the three page application form. For example, instead of attaching letters of appreciation, the applicant will be asked to list letters of appreciation received on the 3 page application form.

Instead of attaching a budget, the applicant will be asked to list expenses/budget/financial items on the application form, etc.

All award information will be updated in Awards Section of the CGCI website in July. And the 2012-2013 CGCI *Yearbook, Manual & Roster*, which will be distributed at the CGCI Fall Board Meeting, will contain the updated Awards Manual.

The CGCI eNewsletter now has 1,295 subscribers; the Consultants eNewsletter has 227 subscribers – 1,522 total subscribers! As you can tell, the eNewsletter subscriber list is growing! Please encourage all of your fellow club members to subscribe to both eNewsletters. They are both filled with important information, which the clubs and districts will want to share. If clubs/districts need newsletter articles, these two eNewsletters are wonderful sources for articles.

#### **Facebook Administrator**

One hundred and seventeen people now "like" CGCl's Facebook page. According to Facebook, the most popular age group who has "liked" CGCl's page is in the 65+ age group! The page is updated daily. Send your blurbs to the Facebook Administrator, and she will post your photos, blurbs, advice, etc. Please ask your club members to place "likes" on the CGCl Facebook page (search for "California Garden Clubs" while on Facebook). If you are not a Facebook member, you can still view CGCl's page – just go to the home page of the CGCl website, lower left corner and click. It contains lots of great info and tidbits for you to put into your club/district newsletter. And remember to send your club/district newsletters to the Facebook Administrator, so she can extract items and place them on Facebook for the whole world to see what your club/district has been doing.

#### **Vonage Account – the 1-888 Number**

Voice mail continues to come to the 1-888 number – some important. This Officer has been weeding through the voice mail and redirecting the important ones to the appropriate chairmen/district directors to handle. This can present serious repercussions for both the club or district as well as CGCI from the IRS, California Franchise Tax Board and Board of Equalization. I think you will agree, none of us want to go down that path so please help us reinforce under no circumstances is any garden club or district to use the name of California Garden Clubs, Inc. or CGCI's EIN.

Pursuing CGCl's objectives is this administration's primary focus. A good example of that is the support received for the CGCl President's Project - permanent signage at Sonoma State University's Native Plant Garden; Project Mission Blue to help save the federally endangered mission blue butterfly by increasing lupine diversity and Phase 2 of the Memorial Garden for the Fallen at Dover Air Force Base. Your support and generosity totals \$25,531 for these three projects adopted.

No one person can take credit for the success of a garden club, district or CGCI. It is strictly a team effort! You are to be commended as we all work together pursuing similar goals and objectives as well as for CGCI as an organization. Again, this president is proud to be included in the team effort demonstrated. Exploring the possibilities in conservation, gardening, creativity and inspiration together is how we can make the difference! As always, it is an honor to serve as your representative.

In addition to lack of volunteers willing to fill the positions of Editor, Assistant Editor and now Circulation Chairman, there is the financial aspect. Golden Gardens costs over \$20,000 to produce four issues a year with a declining subscription base. Both printing and mailing expenses have increased with each issue. When you remove CGCI as the largest subscriber along with its subsidy, only 2,500 members of CGCI's 20,000 members subscribe to *Golden Gardens*. Compare this to CGCI's monthly eNewsletter with 1,400 subscribers that is free of charge to subscribers and less than \$500 a year.

For the 2011-2012 fiscal year, *Golden Gardens* has lost \$5,323. based upon paid subscriptions from 100% clubs and individuals. If *Golden Gardens* is going to continue in its current format, then outside professional layout assistance will be required as well as a significant increase in the annual subscription rate to \$12 for both 100% clubs and individuals. Fiscal responsibility requires that *Golden Gardens* not continue to lose money of this magnitude. The vice presidents will be burdened with serving as Editor of one issue each.

CGCI is not the only National Garden Clubs state organization facing this dilemma. This could be an educational opportunity presenting itself for computer-savvy members within each club to mentor other club members. It may also open a whole new world to members who do not know what is available when they learn to use their computer. Often times this training session can be accomplished over the telephone. 100% clubs will save \$5 a member that may be used to provide those members without computers a copy of *Golden Gardens eNews*. Whether we like it or not, electronic communication is likely our future with less expense. It is a more effective communication tool with timely newsworthy articles that has the potential of reaching more of CGCI's 20,000 members than it currently reaches only four times a year.

The duty of the *Golden Gardens* Editor is to be honest and direct as to the precarious situation *Golden Gardens* is currently in. This chairman urges you to seriously consider both the financial responsibility and volunteers needed to continue *Golden Gardens* because you will decide the future of the publication at this Convention.

#### Bylaws and Policy Committee Chairman – Rita Desilets

Five members of the Bylaws and Policy Committee, Rita Desilets, Chairman, Bev Brune, Sue Bennett, Mary-Jo Noth and Greg Pokorski discuss future proposed Standing Rule and Bylaw changes. We welcome your input for future bylaw changes. Proposed changes to the bylaws must be submitted to the bylaw committee chairman by November 1, 2012 as stated in Article XIX. Sec. 2.

## President's Project - Coordinator Linda Simonds, Chairman Ruth Browning

The CGCI president's educational sign project at Kenneth M. Stocking Native Plant Garden at Sonoma State University has raised \$9,941. towards the goal of installing three signs.

The first goal—the Riparian Habitat sign—has been ordered and is being designed for autumn installation. Writing text and identifying the photographs to use of riparian life at seasonal Copeland Creek has been completed. This project is clearly educational—we rejected a fabulous lesser goldfinch photo because of the noxious star thistle it perched on!

Fundraising for the second sign goal—Fresh Water Marsh/Wetlands—is underway

## **Arboretum, Shirley Stewart**

So far this year, 12 flower shows have been registered and held, with ten receiving evaluation. At least one show took place which was not registered. An argument for registering shows is to validate Judges' claims in their records leading to accreditation, however at present there is no system for communicating registered Standard Flower Shows to the Flower Show Judges' Credentials Chairman. Of course, in addition, many judge flower shows at fairs, which do not register with CGCI and which do not always have panels of three accredited judges; in fact, judges may depend on fairs to receive credit. Flower Show Judges use NGC standards, whatever the setting. There are many CGCI Flower Show Awards offered; clubs can plan their shows with these in mind. Clubs are advised to register their show and have it evaluated; much can be learned by meeting with the judges and hearing their comments. Of course, it is hoped clubs will take the next step and, if eligible, apply for an Award and prepare a Book of Evidence.

Standard Flower Shows are a wonderful way to show off clubs to the public.

# Organizational Meeting 2012 APPENDIX A

## **RULES OF ORDER FOR BOARD MEETINGS, 2012-2013**

- 1. Regular meetings of the board of directors shall be Organizational, Fall, Winter and Pre-Convention meetings.
- 2. Permission for non attendance at any regular meeting shall be obtained from the president.
- 3. Permission for a guest to attend (without voice or vote and provided that they comply with these Rules of Order) any meeting of the board of directors shall be obtained from the president. Guests shall have a special identification.
- 4. Board members (as defined by Article VII., Sec. 1) are requested to be prompt in their attendance. One-third shall constitute a quorum. No member shall be entitled to more than one vote.
- 5. Members and guests shall wear badges to all meetings.
- 6. Oral reports of chairmen and district directors shall be limited to two (2) minutes each unless otherwise announced. All reports shall be in writing. Full-length copies shall be provided for both the President and Chairmen Coordinator. A condensed copy of no more than one hundred (100) words shall be prepared for the Recording Secretary to be attached to the Minutes.
- 7. The president shall appoint a committee of three (3) to review the minutes.
- 8. All cell phones and pagers shall be turned off or set to vibrate during all board meeting functions.
- 9. All but the simplest of motions from the floor shall be in writing and sent to the president or presiding officer, with copies to the recording secretary and parliamentarian, before debate may proceed.
- 10. Whenever practical, motions to be considered for presentation at any board meeting shall be submitted, in writing, to the president with copies to each member of the Executive Committee, to be received at least 10 days prior to such meeting.
- 11. No issue shall be debated without first being placed on the floor by a motion which has been seconded.
- 12. Any member of the board of directors wishing to obtain the floor shall rise and when recognized by the president or presiding officer, shall state his/her name and official capacity.
- 13. If there is an issue involved with any motion on the floor, a duly recognized member may speak no more than twice on the same issue, except for the proponent of the motion, who may speak a third time to close the debate. Speakers shall be allowed two minutes each.

  NOTE: No member may speak a second time until all members who want to speak have spoken a first time.
- 14. The bylaws and standing rules of CGCI, together with *Robert's Rules of Order Newly Revised*, shall govern all proceedings of all meetings of the board of directors.
- 15. These Rules of Order may be suspended at any meeting of the board of directors by a two-thirds (2/3) vote of the board members present and voting, providing that the proposal to be presented is not in conflict with CGCI's bylaws or the fundamental principles of parliamentary law.
