### 2013-2015 President's Project Resolution Habitat for Humanity Landscaping

Whereas, one of California Garden Clubs, Inc.'s (CGCI) objectives is the betterment and beautification of the community; and

Whereas, Habitat for Humanity's mission is to lift working families out of an endless cycle of poverty housing so they can build a brighter economic future; and

Whereas, Habitat for Humanity Affiliates are the agencies that provide affordable housing in small neighborhoods and connect families to social services that provide education and self-sufficiency; and

Whereas, there are forty-nine Habitat for Humanity Affiliate offices located throughout the state of California; and

Whereas, in May of 1999, a partnership was formed between National Garden Clubs, Inc. and Habitat for Humanity, emphasizing enhancement of the environment by landscaping Habitat for Humanity homes with hardy native trees, shrubs and plants that also attract butterflies; and

Whereas, the goal of this president's project is to encourage districts and garden clubs to become involved in the landscaping of Habitat for Humanity homes; and

Whereas, a Habitat for Humanity Landscaping Grant Program shall be established for the 2013-2015 term of office to financially aid clubs and districts seeking funding of up to \$250 to complete a landscaping project; and

Resolved, California Garden Clubs, Inc. adopt "Habitat for Humanity Landscaping" as the 2013-2015 President's Project; and

Resolved, donations from individuals, clubs, districts and businesses shall be held in a CGCI Restricted Fund – "Habitat for Humanity Landscaping" until such time as grant applications are approved and the monies distributed; and

Resolved, all CGCI clubs and districts submit a description of their Habitat for Humanity Landscaping project so a record can be maintained of the scope of CGCI's participation; and

Resolved, any funds remaining in the CGCI Restricted Fund – "Habitat for Humanity Landscaping" as of June 30, 2015 shall be donated to Habitat for Humanity.

#### **Election of Nominating Committee**

Interim Recording Secretary Margaret Strachan read the bylaw pertinent to the election of the Nominating Committee: Article VI, Sec. 2. Nominating Committee: (a) When elected and term of office: 1. A nominating committee of seven (7) shall be elected following the election of officers at the convention in odd numbered years. 2. Term of office of all nominating committee member(s) shall be two years, or until their successors are elected or appointed. b) Eligibility: 1. Each member shall have served on the board of directors and shall be present when nominated. 2. No member shall serve more than two terms and the terms shall not be consecutive. 3. No district shall be represented on the committee two consecutive terms. (c) Election: 1. Following the election of officers, the chair shall call for nominations from the floor. 2. Vote shall be by ballot unless there are only seven (7) members nominated, when election shall be held by voice vote.

7) ARTICLE XI - ANNUAL MEETINGS Sec.11 (Page 139) Now Reads: Sec. 11. Financial records of the convention shall be maintained under the direction of the district convention chairman and shall be reviewed by a member of the Finance & Budget Committee. Copies are to be filed with the president, financial secretary, treasurer, and boards and conventions chairman within 90 days of the close of convention.

8) ARTICLE IV - MEMBERSHIP AND DUES Sec. 3 (a) (Page 133) Now Reads: Sec. 3 (a) Garden Clubs and Associate Plant Societies shall pay annual dues of two dollars twenty-five cents (\$2.25) per capita which shall include dues to NGC, effective July 1, 2008. Amend by deleting "effective July 1, 2008"

To Read: Sec. 3 (a) Garden Clubs and Associate Plant Societies shall pay annual dues of two dollars twenty-five cents (\$2.25) per capita which shall include dues to NGC. Rationale: Simplifies by removing unnecessary wording. **PASSED** 

9) ARTICLE IV - MEMBERSHIP AND DUES Sec. 3 (e) (Page 134) Now Reads: (e) If dues are not paid by October 1, clubs and associate plant societies become ineligible for CGCI liability insurance and participation in the CGCI awards program. In addition, clubs also become ineligible for the CGCI 501(c)(3) IRS Group Exemption. Amend by replacing "501(c)(3) IRS Group Exemption" with "Group Tax Exemption Program."

The last issue of *Golden Gardens* in its current magazine format was the Spring 2013 issue. This final issue included the entire history of *Golden Gardens* from 1931 through 2013 bringing to a close the final chapter of its 82 years.

The subscription list continued to decline. The number of printed copies of each issue was reduced from 4,000 for the 2012 Summer issue to 3,200 for the 2012 Fall issue to 2,700 of the 2013 Winter issue and 2,500 of the Spring 2013 issue. The beginning balance in the *Golden Gardens* checking account on July 1, 2013 was \$28,692.75. The ending balance as of May 20, 2013 is \$19,423.78 for a net loss of \$9,268.97.

President-Elect, Rita Desilets, kindly agreed to serve as Assistant Editor for the 2012 Fall and 2013 Winter issues. Third Vice President Pat Clayes did the layout for the Fall issue; Second Vice President Sue Bennett did the layout for the Winter issue and President-Elect Rita Desilets did the layout of the final and last issue. This president and all three vice presidents worked together as a team these past two years to share the burden of publishing *Golden Gardens* in the magazine format including providing and editing articles, layout of each issue, proofreading, etc.

I would like to recognize those members who served on the Golden Gardens Staff in addition to the vice presidents already mentioned:

Circulation Chairman and Feature Editor of *In a Nutshell* Robin Pokorski, *Golden Gardens* Angels Chairman Carol Mayo, Youth Feature Editor Kris Ethington, Horticulture Feature Editor Dana Lozano, Floral Design Feature Editor Pauline Sechi and Conservation Feature Editor Donna Thomas. Thank you to additional members who provided articles on a variety of subjects.

# CGCI 2011-2013 President's Project Report

At the start of this President's term, the goal of \$22,500 was established to fund the creation of three educational, interpretive signs in the Kenneth M. Stocking Native Plant Garden located at Sonoma State University in Rohnert Park. These photo-quality porcelain enamel signs are set on a concrete base to insure their longevity and graffiti-resistant guality!

To date (5/31/13), \$20,495 has been collected due to the generosity of numerous individuals, clubs and districts. We are continuing to receive funds at this Convention, and still anticipate contributions from our local Sonoma County community. We cannot thank you enough for both your financial support and your belief in this project that reflects CGCI's objectives.

Some of the fundraising has been just pure fun! We thank you for your support through purchases at the *bulb sales* at the 2011 and 2012 Fall Board meetings. We thank you also for your donations and purchases at the *Gently Used Jewelry* event at CGCI's 2012 Winter Board meeting, as well as your donations and purchases at the *Gently Used Garden Books* event at the 2013 Winter Board in Auburn. The beautiful centerpieces at that Winter Board meeting were auctioned to also raise the fund's total. A special thanks to Rene van Rems for providing his book and floral note cards *Rene's Bouquets* at a very special price so that an additional \$500 was added to the project's goal. Additional income was derived from garden club ticket sales to the 2012 and 2013 *San Francisco Flower & Garden Show--*\$1 from each ticket sold by participating garden clubs generated \$1,006.

A complete list of donors as of May 28, 2013 is available at the President's Project exhibit on display in the Exhibit Room, as well as on the CGCI website. We thank you for your generosity—and we will invite you to the campus on a future visit to Sonoma County to see the results of your contributions! Now for the results:

- The *Riparian Plant* community sign base has been installed, and the face was installed last week. (See photo at President's Project exhibit or on the CGCI website.)
- The Wetlands plant community sign was finalized following the 2013 CGCI Winter Board meeting. The text
  and layout has been approved by the campus planning committee. The sign will be finalized over the
  summer with the addition of the required high resolution photographs needed for production. (Again, you can
  see the design at the President's Project exhibit or on CGCI's website.)
- The third sign—Grasslands/Oak Savannah—is only \$2,005 away from being ordered! This final sign will be
  drafted over the summer for approval in the fall by the Sonoma State University campus planning committee.
  Funds will continue to be collected through the end of this convention.

Your support is greatly appreciated, and because of **YOU**, CGCI has made a difference with these three signs focused on educating the community in the value and use of California native plants where no signage existed previously in this four-acre native plant garden.

# CGCI Fundraising Cruise May 11-18, 2013. Sapphire Princess President Julie A. West

Our annual district luncheon "Tea in the Garden" was a huge success.

Club programs included Familiar Land Birds, Chrysanthemum, Ferns, Iris, Bees etc. Field trips to Theodore Payne Foundation, Thousand Palm Oasis and Wind Farms are a few.

Clubs gave monies to Scholarships, schools to start gardens, Arbor Day Celebrations and Penny Pines. We are looking forward to hosting the State Winter Board meeting in February 2014

**Bay Bridges, George Perko:** The Bay Bridges District was 80 years young in 2012-13. It originated as District 4 in 1932. Its 13 member clubs and one youth group had 776 members working industriously on all manner of good deeds for the communities of the San Francisco East Bay: stimulating knowledge and love of gardening among amateurs, aiding in the protection of flora and fauna, encouraging civic planting, assisting in conservation efforts, awarding financial aid to students of horticulture, and assisting other 501(c)(3) charities.

The district held its September organizational meeting at historic Alta Mira House in San Leandro. Hap Hollibough from the Cactus Jungle in Berkeley introduced participants to many unusual cacti and succulents, and 5 clubs had sales tables with beautiful plants, cards, jewelry, and other garden paraphernalia. The sales tables were popular and will be repeated in September 2013.

The April 26 meeting moved to the northern part of the district, El Cerrito. El Cerrito Garden Club sponsored an elegant tea and floral design presentation. 102 members participated, filling El Cerrito Community Center to the brim. When El Cerrito realized how many people were coming, they had an actual rehearsal involving their club members, two weeks in advance of the event. National Garden Club master judges Barbara and Bob Post used flowers from their own garden to create very whimsical designs.

Eight district clubs and gardeners received awards this year. The district was very pleased to issue the first two, \$1,000 Bonita Garden Club/Frances Whyte scholarships to students from Merritt College. The students told participants what they were studying and how the funds would assist their training.

**Bay Ocean, Nancy McDougal:** Each of our member clubs is busy all year with favorite activities. But, just as our gardens bloom afresh, the pace quickens even as the club year is in transition. Clubs often do not meet officially; but projects continue throughout the summer. This is especially vital for fundraising efforts as several clubs earn much of their expenses through participation in the county fair. One group holds its annual garden tour in June, while another is preparing for its popular fall tour. Plant sales also swell the treasury, while providing an opportunity to share plants & become known in the community.

**Buttes, Krystal Migliore:** Water-wise landscaping is the focus of two Garden Club of Colusa County projects. Both PG&E and the City of Colusa asked the club plant areas with drought tolerant plants. One of the sites is Colusa's water tower, which is in a sad state and really needs beautification. Selecting the right plants for the hot, dry climate and including irrigation became the topic of negotiations before either project could move forward. The club's President remarked "It is amazing how many people think that <u>drought tolerant means the plants don't need water at all</u>."

**Cascade, Anne Capes:** One of the clubs in my district is located in the historic town of Weaverville (3600 population) in the Trinity Alps – truly an isolated area. The club has 46 members some of them miles apart. Their projects are primarily community oriented, with one of them taking almost 5 years to complete. The state highway runs right through the middle of town. At the time of the origin of the project – landscaping the borders of the highway (about 850 feet in length) – there was nothing but a ditch full of weeds. It took almost a year to get a permit from Caltrans. Once started there were plans to make for purchase of plants. It should be mentioned that the plan included maintenance

from Day One. Recently there has been a project of quite a different nature, - an educational survey that lists the club's preferences and activities that can be used as a guide when planning and executing a year's program. There are two surveys – Club Priorities and Monthly meeting Priorities. Once the surveys were completed, a member with computer skills put the results into a graph that is visually comprehensive. Issues in Club Priorities are: Monthly meeting, Civic beautification, Community Service, Fund Raising and District Affiliation. Issues in Monthly Meeting Priorities are: Social Luncheon, Guest Speaker, Birds, Inspirational, Horticulture and Business. There is an old saying-"A Picture is worth a thousand words" that is still relevant today. I hope you will find this concept noteworthy when planning your next year's program.

**Channel Islands, Beverly Switzer:** The Channel Islands District is now a 501 (c) 3 approved by the IRS April 28, 2013. My sincere thanks for the assistance and support of the District secretary Margaret Strachan. Also thanks to the District Treasurer Sandy Roth for initiating this task.

Due to the unexpected death of the duly elected treasurer an appointed District Treasurer will be approved at the District's June 19, 2013 meeting.

Each individual club in the C I District continues to serve their membership and community with their own unique programs, ranging from spectacular garden tours, horticulture programs, organic vegetable gardening and push back on Monsanto, tours, community projects, programs for the elderly, flower shows and much, much more. Each club continues to increase it's membership. I leave the Channel Islands District in the very capable hands of Maggie Crane of the Conejo Valley Garden Club.

**Costa Verde, Lorraine Ornelas:** It has been a great pleasure to serve as District Director for Costa Verde District under the capable leadership of Julie West for the term 2011-2013. Our clubs have achieved many of their goals by providing education for their members and their communities. Clubs have participated in Arbor Day programs by planting trees to enhance their communities, honoring individuals or donating funds to organizations that encourage the protection of our environment. Many clubs have supported the Pennies for Pines program by funding plantations in memory of or to honor individuals or organizations that have assisted the clubs.

Several clubs have been awarding beautification awards for landscape gardens for both individual homes and businesses. As a result some clubs have gained new members as a result of this effort.

Earth Day activities were encouraged by some clubs and others participated in community activities. Junior gardeners were encouraged to participate in the Smokey bear and Woodsy Owl contest.

**Desert Empire, Cecile Campbell:** It is with great sadness that the D.E.D. reports the dissolving of our long-standing garden club, the Desert Planters Garden Club of Ridgecrest after 50 years in existence. All of their accomplishments throughout the years cannot be listed here and we will truly miss their contributions to our District and the Greater Garden Club Communities.

We are a District of two garden clubs now as well as a youth garden club.

<u>Oasis Garden Club of Indian Wells Valley and Desert Rose Garden Club of California City.</u> Both clubs during this past year have been busy with their plant sales, garden tours, Teas and Arbor Day planting. Oasis Garden Club of I.W.V. recently purchased a Blue Star memorial Marker that was placed at the Bakersfield National Cemetery on Memorial Day with a well-attended ceremony. The Desert Rose GC of California City has been working on a continuing project of re-doing 4+ miles of median running through California City with irrigation and drought tolerant plants.

**Diablo Foothills, Mona Dunlop:** Our clubs and garden groups celebrated Earth Day with plant sales and tours. Many clubs have had successful fundraisers with garden tours, teas and plant sales.

**DFD** had a successful overnight tour to the Boonie Lang garden in Granit Bay. We were hosted to lunch in Granit Bay by Sue Bennett at her beautiful home. The next day we visited and had lunch at the historic High Hand Nursery in Loomis.

**Our May Board Meeting was** hosted by DIRECTOR–ELECT, Rebecca Ferguson, at her beautiful home in Discovery Bay. We had a wonderful lunch and a boat ride on the Bay.

**Golden Foothills, Josie Goodenow:** A member club of the Golden Foothills District, the Colfax Garden Club, sponsored a Landscape Design School class that was successfully completed in six weeks. The four courses were completed in less than two months, much less time than the previous two-year requirement.

Six weeks is the shortest time frame ever for any club in the California Garden Clubs Incorporated to have completed a Landscape Design School Course. They had 18 students graduate as new Landscape Design Consultants and two Consultants were able to refresh their credentials.

The Golden Foothills District membership now includes 25 accredited Landscape Design Consultants. My heartfelt thanks goes to the school co-chairs Myrtle Findley and Bili Winter and their dedicated volunteers in successfully accomplishing this fast track feat.

Humboldt, Janean Guest: The Humboldt District and its clubs have been busy as always. Fortuna Garden Club hosted its 38<sup>th</sup> annual Daffodil Show in March, and Southern Humboldt Garden Club hosted its 62<sup>nd</sup> annual Flower Show in May.

This spring a bus tour was organized by a local travel agency to the Filoli Gardens, San Francisco Flower and Garden Show and the "Bouquets to Art" exhibit at the De Young Museum in San Francisco. Many garden club members from the district attended and had a wonderful time!

Eureka Sequoia Garden Club planted 18 hanging baskets of petunias to hang in Old Town Eureka and Fortuna Garden Club has been weeding and planting flowers on Main Street as ongoing city beautification projects. The district will be sponsoring Gardening Study School #4 in July. It has been well-attended, educational, fun and helped to raise money for the Humboldt District.

But our Smokey Bear/woodsy Owl contest was a success beyond belief, thanks to Terri Taylor, Youth Chairman for Southern California Garden Club. We had fourteen winners at the state level, four regional winners and three national winners. Much credit has to go to the volunteer art teacher at the school all these children attended.

Of course our district is so proud to have our own Rita Desilets being installed as CGCI president. She has worked so hard for our club and district over the years. We know she will do a fantastic job. Gail Vanderhorst, also a member of So. Cal. Garden Club, is the new Recording Secretary for CGCI. Also Robin Pokorski is the new Corresponding Secretary for NGC.

**Sequoia Foothills, Diane Lane:** Sequoia Foothills District started a mini-grant program in 2012 to become more visable to the incividual clubs in the District and to other members of their communities. The requirement is to do a visible community project which will include a plaque or sign. It also requires matching funds from the local club. This report on Squaw Valley's Four Seasons Garden Club and their project. Funds were used enhance their nature trail behind the local library. A metal plaque was installed on one of four benches with the District's name as a contributor.

#### **Chairmen Reports**

Awards Finance, Win Archibald: The focus for Awards Finance during this period has been on the transition to a new presidential term beginning in June. Commitment letters were sent to current sponsors asking them to re-commit for the new term, 2013-2015. An Awards Finance procedure book has been prepared for the incoming Awards Finance Chairman. Checks for all monetary awards to be given at the 2013 convention have been issued with a date of June 4, 2013 for a total of \$4,280.00. A sponsor of ribbon awards has been invoiced for \$9.50 and payment is awaited. Gift award sponsorships will be invoiced upon receipt of the vendor invoice. As of this date Awards Finance records show a balance for the Awards Restricted fund of \$10,119.41 including \$635.00 in payments for the 2013-2015 term and a carryover balance of \$4,725.20.

The Blue Star Marker has been placed and will be dedicated on Veterans Day.

**California Natives, Margaret Strachan:** This is the time of year when many Native Plants are becoming dormant in order to survive the hot summer months. But thinking ahead to the fall, why not plan to sow some native wildflowers among your native plants. Wildflowers are fast growing and will fill in the gaps while the longer-lived plants mature. To extend the blooming period, after the first fall planting, apply seeds again in December and then as late as mid-February to achieve staggered blooming times throughout the spring. Water gently but thoroughly after sowing and keep the soil moist until a few inches of growth are visible. They may need extra water if there are dry spells during the winter. Some of the flowers have spectacular colors when planted together. Try the California poppy with Baby Blue eyes, or with Arroyo lupines. California poppies also look good when planted amongst perennial grasses. For additional information on growing wildflowers from seed in the garden, consult *Gardener's Guide to California's Wildflowers* by Kevin Connelly, available at Theodore Payne or *Wildflowers of California: a month by month guide* by Laird R. Blackwell, published by The University of California Press, Berkeley.

**Flower Show Awards, Susan Coolidge:** This year seven Standard or Small Standard Flower Shows have been registered and held; five have asked to be evaluated. This number is much lower than previous years, although the majority of clubs having shows in 2013 also held them in 2012 and annually in the past. Flower Show Judges are encouraged to promote flower shows in their regions. This Chairman is grateful to have met so many dedicated people during her tenure; pairing names with faces at CGCI meetings has been a real plus.

**Gardening Consultants Council, Myrtle Findley:** The Gardening Consultants Council Chairman reported the council has dissolved, and will become a part of the new combined councils following Convention 2013.

**Gardening Study Schools, Greg Pokorski:** Series 22, Encino, concluded in March with 34 new Gardening Consultants. Southern California GC realized net revenue of more than \$5,000. Series 23, Eureka, will conclude next month. Series 24 begins next month in Nevada City and will conclude in October. We have seven Gardening Consultants who will lapse at the end of the year if they do not refresh by then. There are GSS articles in every issue of *The National Gardener* and *Keeping in Touch* – some are used in *Consultants eNews*. GSS Curriculum will be reviewed in this 2013-2015 term – please advise if you have suggestions for changes.

**Home Grown, Myrtle Findley:** Home Grown chairman gave a visual report on the screen showing the 'cook off' in February: The cooks, the food stations, cooking and preparing each recipe, the final dishes, all in full color. Recipes have been and will be included in the *eNews*.

This chairman encourages more gardeners to enter their locally grown produce in some sort of dish to be relished at mealtime! Awards Await at CGCI.

Landscape Design Council, Patricia Clayes: At our council meeting on June 6, 2013, the members of the California Landscape Design Council dissolved the council as a separate entity, effective June 7, 2013, and will consolidate, effective June 7, 2013, with the Gardening Consultants Council (that includes Environmental Consultants) to form the California Consultants Council of CGCI, and that all of the assets and liabilities of the California Landscape Design Council will be transferred to the new California Consultants Council of CGCI as of June 7, 2013.

Landscape Design Schools, Alexis Slafer: This Chair is pleased to report that the 26<sup>th</sup> Landscape Design School is being planned. The Luther Burbank District will sponsor this school, beginning in October 2014. There are almost 20 consultants whose credentials will lapse at the end of 2013. Although there is not a current opportunity to attend a school or refresh during this upcoming year, this Chair is available and eager to assist clubs and district members with sponsoring a new school in 2013. There is plenty of time.

Member Award of Distinction, Lynne Hansen: I have issued four Member Award of Distinction certificates. Ms. Sandy Duncan- Chula Vista Garden Club of Palomar District Cecile Campbell- Desert Rose Garden Club of Desert Empire District Raymond Coty- Los Angeles Garden Club of Greater Los Angeles District Josie Goodenow- Golden Foothills District

**Natural Resources, Dwight Holford:** "California's current water supply is clearly vulnerable to many threats, and the cost of its failure would be enormous" said California Natural resources Secretary John Laird. "As public officials, we are duty bound to address these threats. The BDCP (Bay Delta Conservation Plan) provides the most comprehensive, well-conceived approach to ensure a reliable water supply to 25 million people and restoring the Delta ecosystem." The plan also affects 3 million acres of farmland.

All the information about the BDCP is available on the California Natural Resources Agency website. There is enough data about the project to keep one reading for hours. As a group we re also interested in what happens with the environment. Laird also said "Meanwhile we urge Californians to get acquainted with the details of the draft plan and to bear in mind the high costs – from species extinction to water supply disruption of the Delta – of doing nothing. The report says that over 50 years the costs are expected to be \$24.5 billion. The BDCP is a beneficiary pays project. Water users are expected to pay 68% of the total price for design, construction, operation, mitigation, and adaptive management of a new water conveyance system. The remainder \$7.9 billion for habitat restoration, pollution control, anti-poaching programs, and other measures to reduce ecological stress, could be funded through a variety of sources, including state and federal participation. An exact plan is still pending. The plan assumes that California taxpayers would fund the state's share of the non-conveyance costs primarily through passage of two general obligation bonds in future years. This information was extracted from the California Natural Resources Agency website.

**Penny Pines, Pat York:** Hi fellow board members – as you can see by the listings in *Golden Gardens*, the Penny Pines program has become a very popular one with our clubs and their members and they especially like seeing their names listed in our *Golden Gardens* and please do not mix up "In Memory" and "In Honor"!! I really just have one very special request of our District Directors. At our state meetings I give out the simple procedure for submitting the names to me for listing in *Golden Gardens eNews* – PLEASE, forward that information to clubs – since I get numerous emails and mail that should go to some other person re this program, it tells me that the information is not getting to the clubs. It's really a simple process – Collect the monies at your club meetings, select where you want your plantation to be & for whom, and if it is either "In Honor" or "In Memory" or if you do not want one of these, just from your club is fine. Having been a District Director myself at one time with a very good friend, previous director herself, helping me, I do know what our directors should do. Saves me a lot of emails, telephone calls and letters. Since the fires in our forests have already begun again this year, we really do need to continue to support this special program.

Scholarships, Albert Chang: My co-chairman, Evelyn Broaddus, and I have completed our scholarship survey, and we have reported the results to National Garden Clubs. We are justifiably proud that CGCI clubs have provided over \$175,000 for scholarships for this year. Many club presidents and club officers have talked with us during the past year; thank you for providing us with your club's scholarship information.

Here's what we would like district directors and club presidents to do in the upcoming year.

For clubs, currently offering scholarships, please inform us of any changes in your program. Many clubs, including three of my own: Sherman Oaks GC; the West Valley GC; and Southern California GC have increased the number of scholarships and/or the scholarship amounts after successful fundraisers.

For clubs who are currently not offering scholarships, we would like to encourage them to take another look – a relatively small amount of money will encourage our finest students toward achieving their educational goals and help them lead us to a more sustainable future. Consider how important our parent organization, National Garden Clubs, regards scholarship. It is the <u>largest</u> single expenditure made every year. If you do not want to offer a scholarship, consider a donation to the CGCI Scholarship Endowment. Julie, here is my check for \$500.00 to fulfill the pledge of \$1000 I made last year to the Endowment.

I would like to thank President Julie West and all of you for allowing me to serve. I see many friends I have made during my chairmanship. It will be an honor to serve as Scholarship chairman for the upcoming term. It has been a pleasure to work with my co-chairman, Evelyn Broaddus, for the past two years. She is retiring as co-chairman for scholarship after this meeting. Please give a hand for her service to California Garden Clubs, Inc. Thank you.

**Shrubs/Trees, Linda Smith:** Today I want to share with you a fruit tree that is proving to be quite successful at my home orchard in the central valley. It has been on the market approximately 5-6 years. It is called an APRIUM. It is a cross between an apricot and a plum. The fruit is much larger than the normal sized apricot and is so sweet and juicy. It's delicious eaten freshly picked, made into wonderful jam, or frozen to make into cobblers during the winter months. When kept pruned low, there's no need to pull out the ladder - just a reach away for sweetness.

**Smokey Bear/ Woodsy Owl Poster Contest, Denise Davis:** There were over 785 entries in grades 1-5 from California this year. The posters were judged at the winter board meeting in February. The first-place winning posters were sent on to the Pacific Region where 4 of our 5 entries won. Those posters were sent on to the National Garden Club. Nationwide there were 24,324 entries. Three of the entries from California won, including Crystal Baik (grade 4) of Porter Valley School who was the National Grand Prize winner.

This year 10 of the 20 poster winners attended the Youth Recognition Luncheon along with their families.

# Attachment A

# California Garden Clubs, Inc. RULES OF ORDER FOR BOARD MEETINGS, 2013-2015

1. Regular meetings of the board of directors shall be Organizational, Fall, Winter and Pre-Convention meetings.

2. Permission for non attendance at any regular meeting shall be obtained from the president.

3. Permission for a guest to attend (without voice or vote and provided that they comply with these Rules of Order) any meeting of the board of directors shall be obtained from the president. Guests shall have a special identification.

4. Board members (as defined by Article VII., Sec. 1) are requested to be prompt in their attendance. One-third shall constitute a quorum. No member shall be entitled to more than one vote.

5. Members and guests shall wear badges to all meetings.

6. Oral reports of chairmen and district directors shall be limited to two (2) minutes each unless otherwise announced or requested. Written reports shall be submitted via email within two (2) days of the close of the meeting. An abbreviated report of less than one hundred (100) words, emailed to the Recording Secretary, shall be attached to the minutes. Full length reports shall be emailed to the President, *Golden Gardens eNews* Editor, Chairmen Coordinator and/or District Director Coordinator.

7. The president shall appoint a committee of three (3) to review the minutes.

8. All cell phones and pagers shall be turned off or set to vibrate during all board meeting functions.

9. All but the simplest of motions from the floor shall be in writing and sent to the president or presiding officer, with copies to the recording secretary and parliamentarian, before debate may proceed.

10. Whenever practical, motions to be considered for presentation at any board meeting shall be submitted in writing to the president with copies to each member of the Executive Committee, to be received at least 10 days prior to such meeting.

11. No issue shall be debated without first being placed on the floor by a motion which has been seconded.

12. Any member of the board of directors wishing to obtain the floor shall rise and when recognized by the president or presiding officer, shall state his/her name and official capacity.

13. If there is an issue involved with any motion on the floor, a duly recognized member may speak no more than twice on the same issue, except for the proponent of the motion, who may speak a third time to close the debate. Speakers shall be allowed two minutes each. *NOTE: No member may speak a second time until all members who want to speak have spoken a first time.* 

14. The Bylaws, Standing Rules and Policy of CGCI, together with *Robert's Rules of Order Newly Revised* shall govern all proceedings of all meetings of the board of directors.

15. These Rules of Order may be suspended at any meeting of the board of directors by a two-thirds (2/3) vote of the board members present and voting, providing that the proposal to be presented is not in conflict with CGCI's bylaws or the fundamental principles of parliamentary law.

# TO READ: ADVANCED STUDY PROGRAMS (p. 152)

See FINANCES for "Financial Procedure for Sponsoring State Functions" and "Grants and Loans."

Symposia, tri-refreshers/bi-refreshers, landscape design conferences, gardening study forums and environmental conferences are sponsored by CGCI for flower show judges, landscape design consultants, gardening consultants, or environmental consultants in order that they can continue advanced study. Judges and consultants must be members in good standing of a member club and maintain a current subscription to The National Gardener. Subscription to Golden Gardens eNews is also recommended. Any garden club member or the general public may attend the lectures upon Organizational Meeting June 7, 2013 9

paying registration.

# TO READ:

# **GOLDEN GARDENS ENEWS (p.155)**

1. The editor shall departmentalize the work of the publication and select all material for a balanced publication.

2. The CGCI Financial Secretary shall (a) record all monies collected for *Golden Gardens eNews*, (b) pay all bills, (c) send all invoices, and (d) prepare line item entries for inclusion in CGCI budget and financial statements.

3. Circulation Chairman shall (a) maintain database of subscriptions, and (b) process new subscriptions.

4. Golden Gardens eNews Angels and Season's Greetings contributions shall be sent to the Golden Gardens Angels and/or Season's Greetings chairman who shall submit a cash receipt in triplicate. The chairman shall keep one copy for the files, send one copy to the CGCI Financial Secretary, and send one copy and check(s) to the treasurer.

5. Complimentary Angels and/or Season's Greetings require approval from Board of Directors.

## TO READ:

#### CLUB MEMBERSHIP (p. 157)

1. Club Presidents may attend CGCI board meetings without voice or vote.

2. The president of each club, club-at-large, and associate plant society shall receive the CGCI *Yearbook, Manual & Roster, Golden Gardens eNews* subscription information and *The National Gardener*.

3. The president of each affiliate shall receive a CGCI Yearbook, Manual & Roster and Golden Gardens eNews subscription information.

4. All classes of membership are encouraged to subscribe to Golden Gardens eNews.

Procedure for Joining CGCI

1. Applications for membership by clubs shall be made to the membership chairman on an application form which should be signed by the district director (with the exception of clubs-at-large and associate plant societies), and accompanied by dues, made payable to CGCI.

2. Upon receipt of application and dues, the following will be forwarded to the new president: welcome letter, guidelines for treasurer, CGCI *Yearbook, Manual & Roster, Golden Gardens eNews* subscription information, etc. Clubs receive individual membership cards. Associate plant societies receive individual membership cards upon request. Affiliates receive one membership card for their records.

3. New clubs in all membership classes shall be ratified by the board of directors.

# TO READ:

#### **OFFICERS AND BOARD MEMBERS (p. 159)**

2. Oral reports shall be limited to three minutes unless otherwise specified. There shall be three copies: two full-length reports, one for the president, one for the editor of *Golden Gardens eNews*; and one condensed copy of not more than 100 words for the recording secretary.
