Bylaws and Policy Committee Chairman Sue Bennett introduced committee members and announced that the Executive Committee recommends approval of the following amendments to the Bylaws and Standing Rules.

Bylaws and Policy Committee Chairman Sue Bennett moved on behalf of the Bylaws and Policy Committee that the following bylaw amendments be recommended to the voting membership at the 2015 Convention in Reno, Nevada.

PROVISO: proposed bylaw amendment ARTICLE IV – MEMBERSHIP & DUES Sec. 3 (a); shall take effect July 1, 2016, if raising dues from \$.50 to \$1.00 per capita is approved at the National Garden Clubs, Inc. Convention in May 2015. NOTE: if not approved, no change is necessary.

\*\*\*\*\*\*\*\*\*\*\*

#### 1) Now Reads:

Sec. 3 (a) Garden clubs and associate plant societies shall pay annual dues of two dollars twenty-five cents (\$2.25) per capita, which shall include dues to NGC.

*Amend* by replacing "two dollars twenty-five cents (\$2.25)" with "two dollars seventy-five cents (\$2.75)"

#### To Read:

Sec. 3 (a) Garden clubs and associate plant societies shall pay annual dues of two dollars seventy-five cents (\$2.75) per capita, which shall include dues to NGC.

**Rationale:** To include National Garden Clubs price increase in CGCI dues.

Amend by deleting "(a) at no time modify action taken by members at the annual convention;" and renumber remaining items.

#### To Read:

Sec. 2. The board of directors shall be the governing body of this corporation and shall: (a) transact routine business; (b) adopt standing rules; and (c) ratify all classes of membership.

Rationale: To clarify, not necessary since there are bylaw protections for the membership.

## 3) ARTICLE VII - BOARD OF DIRECTORS (page 89)

#### **Now Reads:**

Sec. 7. Business of the board of directors (including all committees and the board of trustees) may be conducted by mail (electronic or postal) or by telephone conference (as long as all members may simultaneously hear each other and participate during the meeting). A report of any action taken by the board of directors by mail or by telephone conference shall be announced and made part of the minutes of the next board meeting.

*Amend* by replacing "telephone conference" with "electronic communication" in both occurrences and replace "as long as" with "provided"

#### To Read:

Sec. 7. Business of the board of directors (including all committees and the board of trustees) may be conducted by mail (electronic or postal) or by electronic communication (provided all members may simultaneously hear each other and participate during the meeting). A report of any action taken by the board of directors by mail or by electronic communication shall be announced and made part of the minutes of the next board meeting.

**Rationale:** To update conducting of meetings and allow for new technological advances **PASSED**

## 4) Article XI – ANNUAL MEETINGS Section 8 (page 91)

#### Now reads:

Convention, registration and credentials chairmen and treasurer, who shall be members of a club in the host district(s), may be appointed by the president upon recommendation from the host district(s) following selection of the convention locale.

Amend by deleting "registration and credentials" in first line and change chairmen to chairman. Add new sentence that reads "Registrar and credentials chairman, may be members of a club in the host district(s) or may be standing committee chairmen appointed by the president."

#### To Read:

Convention chairman and treasurer, who shall be members of a club in the host district(s), may be appointed by the president upon recommendation from the host district(s) following selection of the convention locale. Registrar and credentials chairman, may be members of a club in the host district(s) or may be standing committee chairmen appointed by the president.

**Rationale:** Reduce the number of functions that must be performed by the convention host district. The CGCI Registrar can easily adopt processes established for board meeting registration to handle

convention registration. Credentialing is technical and can be difficult for a host district chairman who does this only once. Confusion can be eliminated and expertise established by having a CGCI board member performs the function annually.

Sec. 4. Interest from investments of scholarship funds shall accrue to the scholarship fund. Interest from all other investments shall accrue to the general fund.

Rationale: Not current practice.

#### Now Reads:

Sec. 6. The budget and finance committee shall: (a) include the financial secretary, who shall serve as the chairman, first vice-president, treasurer, chairman of the board of trustees, and up to three (3) members who shall be appointed by the president; (b) submit the annual corporation budget for adoption at the organizational board meeting; and (c) recommend on proposed transfers or increases to budget accounts or expenditures of money in excess of twenty-five dollars (\$25.00) outside of budget before any action by the board of directors.

Amend by inserting "/president-elect" after first vice-president and insert after board of trustees "Group Tax Exemption Program Chairman"

#### To Read:

Sec. 6. The budget and finance committee shall: (a) include the financial secretary, who shall serve as the chairman, first vice-president/president-elect, treasurer, chairman of the board of trustees, Group Tax Exemption Program Chairman and up to three (3) members who shall be appointed by the president; (b) submit the annual corporation budget for adoption at the organizational board meeting; and (c) recommend on proposed transfers or increases to budget accounts or expenditures of money in excess of twenty-five dollars (\$25.00) outside of budget before any action by the board of directors.

**Rationale**: To include Group Tax Exemption Program Chairman to committee.

Bylaws and Policy Committee Chairman Sue Bennett moved on behalf of the Bylaws and Policy Committee to amend the following standing rules. If passed, the Standing Rules changes become effective immediately.

## 7) SR70 MEMBERSHIP (Page 96)

#### Now Reads:

Membership chairman shall send, by July 1, a list of all clubs, associate plant societies and affiliates with names, addresses, telephone numbers and email addresses of the presidents, treasurers and youth gardener leaders to the president, vice-presidents, corresponding secretary, CGCI Group Tax Exemption Program chairman, *Golden Gardens eNews* circulation chairman, *Golden Gardens eNews* editor, liability insurance chairman, website chairman, yearbook chairman, youth activities

chairman and zip code club finder service chairman. The list should follow the format of the state roster.

Amend by deleting SR70 and replacing it with new SR70

#### To Read:

Membership chairman and/or Communications Director provide reports, as requested, to NGC Chairmen, Pacific Region Chairmen, CGCI officers, District Directors and chairmen.

**Rationale:** To bring up to date.

#### **Now Reads**

An associate plant society shall (1) be a member of a permanent statewide or national plant society, (2) be entitled to representation at annual meeting by its president or alternate, and delegates as specified in Article XI, Section 5, (3) pay annual dues according to Article IV, Sec. 3 (a), (4) be eligible to apply for liability insurance and

(5) not be eligible to apply for CGCI group tax exemption program. In addition, an associate plant society may belong to a district.

Amend by replacing "and" with "," at end of item (4); add a new "(5) be eligible to participate in the awards program and" renumber existing "(5)" to "(6)"; and replace last sentence with "An associate plant society may belong to a district and then shall be classified as a club and pay district dues that shall be at the option of the district."

## To Read

An associate plant society shall (1) be a member of a permanent statewide or national plant society, (2) be entitled to representation at annual meeting by its president or alternate, and delegates as specified in Article XI, Section 5, (3) pay annual dues according to Article IV, Sec. 3 (a), (4) be eligible to apply for liability insurance, (5) be eligible to participate in the awards program and (6) not be eligible to apply for CGCI Group Tax Exemption Program. An associate plant society may belong to a district and then shall be classified as a club and pay district dues that shall be at the option of the district.

**Rationale:** To clarify.

- 90. Job descriptions in the *Yearbook, Manual & Roster* may be changed only with the informed consent of the president and the chairman involved.
- 91. Complimentary copies of the *Yearbook, Manual & Roster* shall be distributed to the board of directors and club, affiliate, and associate plant society presidents; distribution to be determined by the president and *Yearbook, Manual & Roster* chairman. Copies may be purchased from the *Yearbook, Manual & Roster* chairman. They shall not be given or sold to commercial firms.
  92. Major changes in format of the *Yearbook, Manual & Roster* shall be approved by board of directors.

## **Attachment D - Chairman Reports**

### Arboreta and Botanic Gardens, Sherry Molinari

Nearly every great city has a great park. Not so for Los Angeles, until now. As the city core grew into an endless sprawl of industrial buildings, rail yards and ethnic neighborhoods a park was never

in the picture. The city center's one great natural asset, the Los Angeles River, was paved over with concrete 80 years ago.

Today the development of the Los Angeles State Historic Park, 13 years in the making, began in April and is on track for completion late next spring. The scale is modest-32 acres to start, with plans to later connect with other parkland across the L. A. River to create 150 acres of continuous open space in the heart of Los Angeles.

This first phase has a stunning, unimpeded view of the L.A. skyline, the Metro Gold Line running on elevated tracks to the east, Chinatown to the west, Union Station and Historic Olvera St. four blocks distant, the light standards of Dodger Stadium visible across the freeway.

By this time next year, all this will be enhanced by 1,000 trees, a wetland, a citrus grove and open space designed to host festivals and outdoor concerts. The Los Angeles State Historic Park will become a centerpiece for two developing movements in the L.A. urban core. It is at the midpoint of an emerging 52-mile greenway the planners hope will fully developed along the L.A. River.

#### Awards Finances, Launa Gould

Awards Sponsor Statements for the 2014 awards to be given out at the 2015 convention were mailed in August of 2014.

As of January 31, 2015, Awards Finance received \$2740 and it has been reconciled with the CGCI Treasurer. An additional \$235 is outstanding.

## Backyard Habitat, Carolyn Villi

This report is quite a distance from my chairmanship of Backyard Habitat; but it involves our wildlife and our planet and that makes it important to this chairman. Quite by accident I have witnessed something that's being promoted as the turning point in green energy, when actually it's a terrible waste of our government's money (our tax money) and a disaster for our bird and animal population.

Our government convinced one of the central valley oil companies, along with funding from Good Old Uncle Sam, to build a solar tower in the Coalinga oil field. The plant uses power tower technology that trains concentrated solar power onto steam boilers. The estimated cost to build was 90 million dollars. With much interest of all the people working in that area the tower was built, the cost running into more than \$300 million.

Do we really want this power, do we want to live on a bird free planet? There is a plan to put a 75 ft. story solar tower near California's Joshua Tree National Park, its now on hold. The state of Oregon is much smarter than California. They have outlawed these Bird-Killing Towers from coming into their state. We as educated gardeners need to always ask questions when learning of some earth changing technology. Where will it go? What damage can it do? How much will it cost our taxpayers and will it pay for it's self in our children's, grandchildren's and great-grandchildren's lifetime's???

## Bee Chairman, Josie Goodenow

Are you aware that native bee populations are in decline? There are many potential reasons for this. We may <u>never</u> know what caused so many bees to die but we know how we can help. Bee Gap, a partnership between National Garden Club and Crown Bees, brings us information in an educational and entertaining format.

Club members love the program but I need help! My goal is to have one Bee Chairman in every District.

Folks must be made aware of the importance of our pollinators. 1/3<sup>rd</sup> of our food is directly dependent on pollinators! Will you help?

# Habitat for Humanity, Sara White

CGCI President Rita Desilets' project, Habitat for Humanity Landscaping, has about 3.5 months to go before its completion. Since June 2013, we have collected \$6,660 in donations and we have granted out \$1,000 to four clubs. If there are any clubs or districts which have participated in a landscaping project without applying for grant money, please let this chairman know so they can be recognized for it.

All donations and grant awards must be completed by June 1, 2015.

### Scholarship, Albert Chang

The Scholarship committee has awarded the Julie A. West Scholarship to David Jaeckel, an environmental studies graduate student at Yale University. The committee awarded the Robert Gordon Scholarship to Kelly Meehan, a graduate student in ecology and environmental management at the Nicholas School of the Environment at Duke University. Clubs, districts and associate plant societies are asked to donate funds for the CGCI Scholarship Fund and the CGCI Scholarship Endowment Fund. #### **Water Conservation, Marlene Kinney**

Water = Liquid Gold

The historic California water crisis is now in its fourth year and daily makes the front page news. Unfortunately, most of the news is negative, no rain in the Bay Area for all of January. Farmers, our State's backbone, are using water from aquifers (essentially, a non-renewable resource) at an alarming rate while others are having their wells run dry. In urban areas the water providers lose about 23 billion gallons a year. The infrastructure is decades old and in need of \$1trillion in repairs and upgrading over the next 25 years. The most obvious and costly example was the catastrophic water main break last summer at UCLA with 20 million gallons of water wasted. Fact: our water districts can add an additional tax assessment to our property taxes without our approval, and are moving in that direction.

We need to ask if the passage of Propositions 1 & 2 in 2014 sufficiently defines <u>California State</u> <u>Water Policy</u> balancing today's needs and future consumption. Towns are approving large new building projects. Farmers are planting new water intensive crops in fields previously planted in seasonal crops. There are plans to expand the leases for oil fracking, the injection of water and chemicals into the ground to extract oil. Many of our manufacturing processes take lots of water, in many cases, contaminating the residual waters.

Become informed. Share information. Speak up. If we do not work together we all lose.
